Dr. Boniecki called the meeting to order at 1:50 pm

Action Items:

- Dr. Shires, on behalf of subcommittee I, moved to recommend a proposal from the Computer Science department to change the credit hours requirements in the computer science minor from 20 to 18 hours. Ms. Nick seconded the motion. Motion passed, 10 in favor, 1 abstention, 0 opposed.
- 2. Dr. Shires, on behalf of subcommittee I, moved to recommend a proposal from the Geography department to change the credit hours requirements in the Geography major from 36 to 37 hours. Ms. Close seconded the motion. Motion passed, all in favor.
- 3. Dr. Ryburn, on behalf of subcommittee II, moved to recommend a proposal from the Office of the Provost for a change to the transfer credit policy in the Undergraduate Bulletin. Dr. Fayman seconded the motion. Motion passed, all in favor.
- 4. Dr. Ryburn, on behalf of subcommittee II, moved to recommend a proposal from the department of Languages, Linguistics, Literatures & Cultures for a new Linguistics minor in Teaching English to Speakers of Other Languages (TESOL). Dr. Fayman seconded the motion. Discussion followed. Motion passed, all in favor.
- 5. Dr. Ryburn, on behalf of subcommittee II, moved to recommend a proposal from the department of Languages, Linguistics, Literatures & Culture/Modern Languages-French and Spanish to drop the required minor for students completing two concentrations in the Modern Languages BA degree. Dr. Fayman seconded the motion. Motion passed, all in favor.
