Dr. Boniecki called the meeting to order at 1:00 pm.

Dr. Talbot seconded the motion. Discussion followed. Motion passed, 17 in favor, 1 abstention.

- 5. Dr. Reid, on behalf of subcommittee II, moved to recommend a proposal from the College of Liberal Arts for a new degree program, the **Bachelor of General Studies**. Dr. Talbot seconded the motion. Discussion followed. Motion passed, all in favor.
- 6. Dr. Reid, on behalf of subcommittee II, moved to recommend new course proposals from the Department of Health Sciences/BS in Nuclear Medicine Technology for NMT 4102 Medical Ethics and Law and NMT 4101 Medical Terminology. Dr. Frederickson seconded the motion. Motion passed, all in favor.

 - c. Increase the minimum GPA from a 2.5 to a 2.75 for admission.
 - d. Add NURS 3102 as required course for prelicensure BSN degree.
 - e. Add NURS 3405 as required course for prelicensure BSN degree
 - f. Remove NURS 3201 as required course for prelicensure BSN degree
