Dr. Boniecki called the meeting to order at 1:40 pm.

Action items:

- Dr. Magimairaj, on behalf of subcommittee one, moved to recommend a proposal from the College of Liberal Arts/Bachelor of General Studies for new course GEST 4380 General Studies Capstone. Dr. Rowley seconded the motion. Motion passed, all in favor.
- 2. Dr. Magimairaj, on behalf of subcommittee one, moved to recommend a proposal from the School of Nursing to add NURS 4315 Research and Evidence Based Practice to the UCA Upper Division Core as an elective in the category of Critical Inquiry and Effective Communication. Dr. Reid seconded the motion. Motion passed, all in favor.
- 3. Dr. Magimairaj, on behalf of subcommittee one, moved to recommend a proposal from the History department for new course **HIST 3390** Introduction to Historical Writing. Dr. Reid seconded the motion. Motion passed, all in favor.
