<u>1. MAcc Partners Scholarship</u>

Every student who meets the criteria and applies by the deadline will be awarded this scholarship unless they receive another MAcc scholarship. The MAcc Partner Scholarships are funded by donations from BKD, LLP; Hudson, Cisne, & Co. LLP; and Thomas & Thomas LLP.

Award

• \$750/semester for two semesters (does not include summer)

Application Criteria (first semester)

- Full or concurrent MAcc admission
- Enrolled in 9 graduate hours
- GPA of 3.0 with no Cs on any completed on MAcc coursework

- One-page Resume

Progression Criteria (for 2nd installment)

- Completed 9 MAcc hours
- Enrolled in 9 (or remaining) graduate hours
- MAcc GPA of 3.0 with no Cs
- No need to reapply

2. Stephens Bell Scholarship

This is a competitive scholarship awarded to a deserving MAcc student selected by the scholarship committee. The student who receives the Stephens Bell Scholarship cannot also receive another MAcc scholarship. The Stephens Bell Scholarship is funded by an endowment from Bell & Co.

Award

• Up to \$4500 to be paid over three or more semesters (includes summers)

Application Criteria (first semester)

• Full or concurrent MAcc admission

Progression Criteria (for future semesters)

- Progress toward graduating with a 3.0
- No need to reapply

- One-page Resume
- Personal statement about how the Stephens Bell Scholarship will affect your life today and in the future (not to exceed 500 words)

APPLICATION DEADLINE

Completed applications must be received by the UCA Accounting Department by the first Tuesday of the new semester. Deliver or mail to UCA Accounting Department; 210 Donaghey COB 204; Conway AR 72035

Students will be notified of award by letter and the funds will be credited to the students' accounts approximately three weeks after the beginning of the semester.

Students seeking the second installment of a scholarship awarded in a previous semester need not apply again. The second installment is automatic if the recipient meets the scholarship's progression criteria.

Students who were denied a scholarship in a previous semester for any reason must reapply if they now meet the eligibility criteria and wish to be considered again.
