After discussion of the court order from Pulaski County Circuit Judge Perry Whitmore to release the names and make applications available for public review, Mr. White made a motion to comply with the court order asking for clarification about what information to release. The motion was seconded by Mr. Branscum. Voting in favor of the motion were Mr. White and Mr. Branscum. Voting against the motion were Judge Jones and Dr. Chakales. Chairman Ahlf declared a tie and voted against the motion. The motion failed by a 3-2 vote.

A motion was made by Dr. Chakales to appeal Judge Whitmore's order which was seconded by Judge Jones. Voting in favor of the motion were Dr. Chakales and Judge Jones. Voting against the motion were Mr. Branscum and Mr. White. Chairman Ahlf declared the tie and voted in favor of the motion. The motion was adopted by a 3-2 vote. Dr. Chakales moved to amend the motion to appeal on the basis and merit and not on the procedural basis and grant a judicial clarification on what information was to be released from the applications if the court order is not by negotiation changed from a writ of mandamus to a declaratory judgment. The motion for the amendment was seconded by Judge Jones. Voting in favor of the motion were Dr. Chakales and Judge Jones with Mr. Branscum and Mr. White abstaining. Chairman Ahlf declared the motion adopted by a 2-0 vote.

The following resolution was adopted upon motion made by Mr. White, seconded by Judge Jones, and passed:

"BE IT RESOLVED: The Board of Trustees directs the administration to implement a 2.5% merit increase to University employees, with the exception of newly hired employees, in keeping with merit increases authorized by the Department of Finance and Administration in their memorandum of August 5, 1987, to be implemented as early as the Finance and Administration Department will authorize such action."

A motion was made by Mr. White to state that the intention of the Board and the previously passed motion dealing with merit raises would not apply to newly hired individuals, those on step 10, and those on line item maximum. This is to be implemented in keeping with the spirit and intent of the memorandum from the Department of Finance & Administration. The motion was seconded by Judge Jones, and passed.
