Upon motion made by Trustee Norman and seconded by Trustee Ahlf the minutes of the last meeting of the Board of Trustees were approved by unanimous vote.

Upon the recommendation of President Snow, Trustee Johnson made a motion that the College enter into a contract with Minute Man of America, Inc., doing business as Scramble Snack System to install and operate in the Student Center Building a fast foods service for the convenience of the faculty and student body of the College. A second to this motion was made by Trustee Mitchell and passed by unanimous vote.

After full discussion, motion was made by Trustee Johnson and seconded by Trustee Sneed that the College contact the State Insurance Commissioner to determine the financial stability of Financial Security Life Assurance Company in Little Rock prior to negotiating a student accident and health insurance plan. Based upon these findings passage of motion approving this transaction to be subject to a subsequent poll of the Board. Motion passed by unanimous vote.

Trustee Ahlf made a motion that the Agreement Between Owner and Architect (Mr. Bruce R. Anderson) on a "Health and Physical Education Center," Project No. 5-7-00445-0, be approved. A second to this motion was made by Trustee Norman and passed by unanimous vote.

Trustee Sneed made a motion directing the College to purchase Bonds with funds deposited in the Union National Bank, Little Rock, in the amount of \$315,000.00. Said Bonds to be replaced by State Appropriated Funds, Appropriation Code 0-525-201-000-5. A second to this motion was made by Trustee Mitchell and passed by unanimous vote.

Upon motion made by Trustee Mitchell, seconded by Trustee Sneed and passed by unanimous vote, the College is authorized to accept and administer Federal grants.

A motion was made by Trustee Mitchell that the Health and Physical Education Center, Project No. 5-7-00445-0, be named the "Jeff Farris Health and Physical Education Center." A second to this motion was made by Trustee Ahlf and passed by unanimous vote.

Upon motion made by Trustee Norman, seconded by Trustee Mitchell and passed by unanimous vote, Estes Field will be known hereafter as Estes Stadium.
