In executive session Trustee Mitchell made a motion, seconded by Trustee Morgan and passed by unanimous vote that the contract of President Silas D. Snow be for a period of three years beginning July 1, 1972. Salary for the month of July, and for as many months thereafter during the fiscal year ending July 1, 1973, as funds are available, will be \$1,791.66. For the fiscal years 1973-74 and 1974-75 his salary will be the figure as established in the State College of Arkansas Appropriation Act. Furthermore, for the convenience of the Board of Trustees President Snow is required to live in the President's Home for which no rent nor utilities are to be paid.

Motion was made by Trustee Mitchell, seconded by Trustee Sneed, and passed by unanimous vote that open meeting of the Board be declared.

In open meeting, Trustee Mitchell made a motion, seconded by Trustee Morgan and passed by unanimous vote that the contract of President Silas D. GRADUATE COUNCIL

Membership: Twelve members appointed by the Committee on Committees:

- Four department chairmen, each recommended to the Committee by his respective college dean;
- (2) Four department chairmen selected by the Committee, one each from the four colleges;
- (3) Four graduate faculty members with the rank of assistant professor or above, appointed by the Committee, one each from the four colleges.

The Dean of Graduate Studies will serve as chairman of the Council. The Council will elect its secretary. The Vice President for Academic Affairs and the Registrar will serve as ex officio members.

Membership terms of office

Each council member will serve four years after an initial period of shortened rotation. The four college representatives nominated from each of the three classes of members will serve one, two, three, or four years according to a random selection:

> The random selection will begin with the departmental chairmen recommended by their deans. The terms thus determined will set a matrix, with the next two classes of members staggered one year later for each.

Meetings: On call by the Chairman.

Responsibilities

- (1) To review and recommend to the Council of Deans new graduate curricula and programs proposed by the various departments and colleges; to recommend revision of existing graduate curricula and programs when desirable.
- (2) To initiate and recommend policies and procedures relevant to graduate degree requirements, grading and credit policies, academic standards, and related matters.

UNDERGRADUATE COUNCIL

Membership:Twelve members appointed by the Committee on Committees:(1)Four department chairmen, each recommended to the Committee
by his respective college dean;

- (2) Four department chairmen selected by the Committee, one each from the four colleges;
- (3) Four faculty members with the rank of assistant professor or above, appointed by the Committee, one each from the four colleges.

The Dean of Undergraduate Studies will serve as chairman of the Council. The Council will elect its secretary. The Vice President for Academic Affairs and the Registrar will serve as ex officio members.

Membership terms of office

Each council member will serve four years after an initial period of shortened rotation. The four college representatives nominated from each of the three classes of members will serve one, two, three, or four years according to a random selection:

> The random selection will begin with the departmental chairmen recommended by their deans. The terms thus determined will set a matrix, with the next two classes of members staggered one year later for each.

Meetings: On call by the Chairman.

Responsibilities

(2) To initiate and recommend policies and procedures relevant to baccalaureate degree requirements, grading and credit policies, academic standards, and related matters.

COUNCIL OF DEANS

Membership: The deans of each of the four colleges, and the deans of undergraduate and graduate studies.

The Vice President for Academic Affairs will serve as chairman.

The Council will elect its secretary.

Meetings: On call by the Vice President for Academic Affairs.

Responsibilities:

- (1) To review and recommend to the President new curricula and educational programs, program revisions, degree requirements, and academic standards approved by the undergraduate and graduate councils.
- (2) To coordinate all academic matters to the end that the objectives of the total institution are achieved. The Council is empowered to direct the undergraduate and graduate councils toward the initiation or revision of academic programs, policies, and procedures to achieve these institutional objectives.
- (3) To recommend to the President the granting of awards from the Faculty Research Fund as proposed by the screening committees of the Colleges.

By motion of Trustee Ahlf, seconded by Trustee Morgan, and passed by unanimous vote the following Early Admission Program was established:

State College of Arkansas offers an opportunity for high-ability secondary school students who have completed six semesters of secondary school to enroll at the college as full time students. Upon earning twentyfour (24) semester hours of college credit the student will be granted a High School Diploma.

Eligibility: To be eligible for early admission to State College of Arkansas a student must:

- complete six semesters of high school with a <u>B</u> or better average,
- (2) have an ACT Composite Score of at least 24, and
- (3) be recommended by his high school principal.

How to Apply: To be admitted to the program, eligible students must complete and return the following forms.

- (1) Application for admission to State College of Arkansas.
- (2) Health Examination Record
- (3) Personal Data Form
- (4) Recommendation for Early Admission. (This form must be completed in triplicate and each copy signed by both the student and his high school principal. All copies of this form and a six-semester high school transcript must be mailed by the principal).

Notice of Acceptance: As soon as all the forms, properly completed, and an official report of ACT scores, sent from ACT, have been received, the recommendation forms will be approved by the college and one copy will

be returned to the student and one to the principal. An approved

Trustee Mitchell made a motion that effective July 1, 1972 the campus post office contract be renewed in the name of State College of Arkansas. A second to this motion was made by Trustee Morgan and passed by unanimous vote.

A motion was made by Trustee Mitchell, seconded by Trustee Morgan and passed by unanimous vote authorizing college administration to advertise for bids for sale of the present home economics home management house located in Conway, Arkansas.

Trustee Mitchell made a motion that the College become liable for unemployment insurance effective January 1, 1972; e.g., that the College would be self-insured. The method of establishing a reserve fund to pay claims for those employees who have met requirements to draw unemployment as a result of working for State College of Arkansas would be established at a rate of 2 per cent based on the total regular payrolls until the reserve fund has reached \$50,000. At that point it will be studied to determine what per cent should be used in order to continue to maintain this fund. A second to this motion was made by Trustee Sneed and passed by unanimous vote.

Trustee Ahlf made a motion authorizing the temporary location of the College of Business and the permanent location of the Department of Home Economics in McAlister Hall. The motion further stipulated that the present football dressing rooms located in the gymnasium be renovated. A second to this motion was made by Trustee Mitchell and passed by unanimous vote.

Mr. John C. Echols representing Mr. Herschel Friday, Bond Attorney, presented "OFFICIAL NOTICE OF SALE AND STATEMENT OF ESSENTIAL FACTS" and "RESOLUTION" relative to the construction of a Business Administration Center. Motion was made by Trustee Mitchell, seconded by Trustee Johnson, and passed by unanimous vote authorizing official signatures on above named documents.

Mr. B. W. Horton, Vice President for Financial Affairs, gave a financial report as of February 29, 1972, and distributed copies of same.

There being no further business to come before the Board, upon motion made by Trustee Sneed, seconded by Trustee Morgan and passed by unanimous vote meeting was adjourned.
