Trustee Morgan made a motion that President Snow be authorized to fill vacancies for the summer session of 1963, for 1963-64, and to be formally acted upon at subsequent meetings of the Board. This motion was seconded by Trustee Hoggard and unanimously passed.

President Snow presented the following personnel to be considered for summer appointments:

Mary Ellen Burton, first summer term @ \$100 per week in the Department of Education.

Mrs. Frances Elmer, first summer term @ \$100 per week in the Department of Education.

Terrell Powell, second summer term @ \$120 per week in the Department of Education.

A motion was made by Trustee Mitchell, seconded by Trustee Hoggard and unanimously passed that the above recommendation be approved.

Trustee Mitchell made a motion that the college trade in three old cars when funds are available. The motion was seconded by Trustee Halbrook and passed unanimously.

A motion was ma de by Trustee Mitchell and seconded by Trustee Hoggard that the college explore the most advantageous manner to obtain I.BM. data processing equipment, i.e., by outright purchase, lease purchase, or option to buy to be exercised later and be authorized to enter into such. This motion was passed by unanimous vote.

The motion was made by Trustee Mitchell, seconded by Trustee Morgan and unanimously passed that administrative officials of the college explore the possibilities of establishing a tax sheltered annuity program for staff members of the college.

A motion was made by Trustee Halbrook, seconded by Trustee Mitchell, and unanimously passed that the business manager and the accountant of the college purchase and initial a mechanical bookkeeping system that will enable the college to modernize its system of accounting. The estimated cost of this project is up to \$18,000.00.

A financial report of the college was presented by Harold D. Eidson, Business Manager.

Dr. A. E. Burdick, Dean, gave a report on the academic affairs of the college.

Trustee Harper made a motion that the position of Security Officer be declared vacant. This motion was seconded by Trustee Mitchell and unanimously passed.

President Snow recommended that the position of Security Officer be offered to Marvin Iburg at a salary of \$4,000 annually plus a college owned house and utilities. A motion including the above information was made by Trustee Mitchell, seconded by Trustee Hoggard and unanimously passed. A motion was made by Trustee Mitchell, seconded by Trustee Hoggard and unanimously passed that \$50,000 of the \$1,200,000 appropriated for the new library be used to purchase books for the library during the next two years and that the remainder left from the library construction fund amounting to approximately \$150,000 be applied on complete renovation and modernization of the old administration building that is now known as "Main."

A motion was made by Trustee Harper to order the remainder of library furnishings amounting to approximately \$93,000 as quickly as the State Comptroller's Office approves such. This motion was seconded by Trustee Halbrook and unanimously passed.

Trustee Morgan made a motion, seconded by Trustee Hoggard and unanimously passed that the site immediately west of the old B. W. Torreyson Library be approved for the construction of the W. C. Ferguson Memorial Chapel if concurred in by the ASTC Endowment and Trust Fund.Board.

A motion was made by Trustee Mitchell that beginning September 1, 1963, the account carried in the Business Office as New Building Fund of 1962 (for which a \$5 Building Fee has been collected since September, 1962) is to be increased to \$9.50 in order to conform to the new regulation of \$90 per student per semester and of this money already collected and credited to the account the amount of \$\$12,000 is to be transferred to the W. C. Ferguson Memorial Chapel Fund. Upon a second to this motion by Trustee Harper it was passed unanimously.

A motion was made by Trustee Mitchell and seconded by Trustee Halbrook authorizing the development of plans for the new men's dormitory to include five large study rooms if financing for same can be arranged satisfactorily. This motion was passed unanimously.

The matter of the investment of the Dormitory Reserve Account now being held in the Union National Bank, Little Rock, Arkansas, was brought to the attention of the Board. Since the amount of this balance had reached \$95,000 and since Government Securities are the only thing that the Bond Indenture permits us to invest in, a motion was made by Trustee Mitchell and seconded by Trustee Morgan that Trustee Harper and Harold D. Eidson be authorized to invest this money in Government Securities in accordance with their best judgement. This motion was passed unanimously.

There being no further business to come before the Board, the meeting was adjourned.
