The Board of Trustees of The Arkansas State Teachers College met in the President's office, Thursday, March 24, 1960, pursuant to legal call of the meeting by the Chairman. After a discussion of the proposed trust indenture, Mr. Wallace Townsend, Attorney, stated that the resolution incorporating the form of the indenture would be adopted after the bond issues were actually sold to the Housing and Home Finance Agency. Mr. Harper raised the question that since the local banks in Conway were to be paying agents, they should be Trustees of the issues also. After some discussion, on motion made by Mr. Harper, seconded by Dr. Halbrook and unanimously carried, it was resolved that the trusteeship of the Series "A" bonds be offered to the First State Bank of Conway and that the trusteeship of the Series "B" bonds be offered to the First National Bank of Conway, and that if either banks declined, the Union National Bank of Little Rock, Arkansas, should be elected as trustee for that issue.

RESOLUTION BY THE BOARD OF TRUSTEES OF ARKANSAS STATE TEACHERS COLLEGE COVENANTING TO ESTABLISH AND ENFORCE SUCH PARIETAL RULES AND REGULATIONS AS WILL ASSURE MAXIMUM OCCUPANCY AND USE OF THE FACILITIES AND SERVICES TO BE AFFORDED BY CERTAIN DORMITORIES, THE REVENUES OF WHICH WILL BE PLEDGED TO THE BOARD OF TRUSTEES OF ARKANSAS STATE TEACHERS COLLEGE DORMITORY BONDS OF 1960, SERIES "A" AND SERIES "B".

WHEREAS, the Board of Trustees of Arkansas State Teachers College is authorized to enter into an agreement relating to the maintenance of a maximum percentage of occupancy and use of the dormitories, the revenues from which will be pledged to payment of principal of and interest on bonds of said College; and

WHEREAS, the Board will authorize the issuance of \$765,000 Board of Trustees of Arkansas State Teachers College Dormitory Bonds of 1960, Series "B", for the purpose of providing on the campus of the College at Conway, Arkansas, a new men's dormitory building, including necessary facilities, designed to house approximately 126 men students and a supervisor, and a new women's dormitory building, including necessary facilities, designed to house approximately 124 women students and a supervisor (the two buildings hereinafter sometimes called the "Project"), and \$325,000 of Board of Trustees of Arkansas State Teachers College Dormitory Bonds of 1960, Series "A", for the purpose of refunding at the same interest rate they now bear a like amount of Board of Trustees of Arkansas State Teachers College Dormitory Bonds of 1957 (the two series are hereinafter sometimes called the "Bonds"), and will pledge the gross revenues from the Project and from an existing dormitory known as "Minton Hall" to the payment of the principal of and interest on the Bonds; and

WHEREAS, the Board will covenant with the prospective holders of the aforesaid Bonds that it will at all times while the Bonds are outstanding establish and maintain such parietal rules for the aforesaid dormitory facilities as are necessary to assure maximum occupany and use of said dormitory facilities; now, therefore,

That in the event more facilities or space should become available for dormitory purposes than are required by students applying for such space or facilities, the officers of the College are hereby directed to give preference and priority to the use of the facilities of the Project and Minton Hall, resulting to the extent practicable in the occupancy and use of all the space and services of said dormitories even if such preference results in the non-use of all or a part of the space or facilities available at the College in any other dormitory or any other building which may be suitable or useable for dormitory purposes.

3. That to the extent that any surplus space or facilities shall ever become available in the said dormitories while any of the Bonds remain outstanding and unpaid, it shall be the duty of the officers of the College to enforce a rule requiring occupancy and use, to the extent practicable, of said Project and Minton Hall by students attending the College, and this provision shall be considered as a rule for guidance of said officers.

4. That the officers of the College are hereby directed to utilize and to cause the utilization of said Project and Minton Hall in such manner as they will yield the maximum revenues of which they are reasonably capable, to the end that the Bonds may be adequately serviced.

5. That such rules shall be amended from time to time as the conditions arise so as to meet changing conditions, better to assure the fulfillment of this pledge.

IRBY DEMONSTRATION SCHOOL SICK LEAVE POLICY

Each member of the Irby Demonstration School acquires one day of sick leave for each month he or she works. However, in no instance shall a teacher accumulate more than 18 days of sick leave at one time. He or she can work two full school years without absence at which time they have acquired 18 days of sick leave.

This sick leave can be used only in case of personal sickness, sickness in the immediate family, or death of a near relative. This, as well as other absences, must be reported to the Director of the Demonstration School who will get a substitute for the teacher. All substitutes must be paid for their services through the Business Office.

The motion was seconded by Trustee Mitchell and unanimously passed by the Board.
