The Board of Trustees, arkansas State Teachers College, met in Room 1414, McGehee Hotel, Little Rock, arkansas, at 10:30 a.m. Wednesday, April 8, 1942, pursuant to written notice authorized by Chairman Bachelor.

The following members of the Board were present: George Bachelor, chairman; Bruce Kendall, Secretary; J. T. Bateman; R. A. Cox; Mrs. George F. McKinney and Dr. A. M. Elton. Absent: Chas Maze.

President Irby was also present.

Chairman Bachelor announced a cuorum and after the reading and approval of the minutes of the previous meeting of the Board, declared the Board ready for business.

Trustee Kendall made a motion which was seconded by Trustee Elton that the Board accept the action of President Irby in fixing the salary of Dean W. C. Ferguson at \$227.50 per month until July 1, 1942; Mrs. Leslie P. Bigelow, as acting Dean of Women, at \$148.00 per month until July 1, 1942; accept resignation of Mrs. Mary Richardson, Hostess Bernard Hall; and temporary assignment of Miss Nell McGregor as her successor; and grant George Connell, High School Supervisor, a three year leave of absence as of March 7, 1942. Arrangements as to his salary and position when he returns to the college are to be left to be determined by conditions that exist at his return. The motion carried.

Trustee Elton made a motion which was seconded by Trustee McKinney that President Irby should receive the pay for the use of servants quarters at the President's Home to apply on his own rental of the Home. The motion carried.

The Board unanumously passed a resolution giving President Irby authority to determine salary adjustment in the case of staff members who are absent from duty because of illness or other reasons and that the price of board for students in the Commons for next year is left entirely to the administration at the college.

Trustee McKinney made a motion which was seconded by Trustee Elton that a major in Business Education be offered at the college. The motion carried.

The Board accepted the report of President Irby that the experiment of a cooperative undertaken on the campus for girls from needy families has not proved to be an unqualified success. Five or six girls from the total have been sent home this year for conduct which the college could not permit. The general morals of the girls has not been very high due to considerable bickerings and minor quarrels among themselves. The cooperative should be maintained at least one other year to see whether or not it can be continued without too much difficulty.

Trustee Kendall made a motion which was seconded by Trustee Elton that Miss Daisy Bruce be elected as secretary in the Extension Department at a salary of \$75.00 per month, effective from March 2, 1942 to July 1, 1942, to succeed Mrs. Ethelyn Dollar, resigned. The motion carried.

Trustee Cox made a motion which was seconded by Trustee Kendall that President Irby and Chairman Bachelor be authorized to enter into contract with the Board of Directors of the Conway School District for the training of practice teachers in the local schools. The motion carried.

Trustee Elton made a motion which was seconded by Trustee Kendall that the personnel committee composed of Chairman Bachelor, Trustee Cox and President Irby be authorized to fill vacancies, if such occur in college personnel, considerably in advance of either regular or special meeting of the Board. The motion carried.

Applications for the position as Hostess in Bernard Hall were presented to the Board. Trustee Kendall made a motion which was seconded by Trustee Elton that no additional hostess be employed until it is determined what the enrollment is going to be next year. The motion carried.

The Chairman announced that it will be the policy of the Board to work with the Federal Government and assist in every way possible in the housing of soldiers in Doyne Hall if such request is made by the Federal Government, and appointed the following committee to act with the Federal Government for the college: Trustee Bachelor, Trustee Cox and President Irby.

Trustee Cox made a motion which was seconded by Trustee Kendall that President Irby accept the invitation of the Kellogg Foundation to attend the Foundation's expense a school for college presidents at Kalamazoo, Michigan, for two weeks beginning on June 14, and accept the invitation of Peabody College to conduct a meeting of officials from all the Southern States on that campus on July 24 at the expense of the college. The motion carried.

Trustee Cox made a motion which was seconded by Trustee McKinney that the college not buy films which are now in the film library on the campus from Erpie Classroom Films, Inc., but to pay annually rental fees regularly charged for the use of these films in other schools in the State and that Erpie Inc., is to be notified that this rental fee is not to apply on the purchase of the film library, but to be applied only for rental. The motion carried.

Trustee Kendall made a motion which was seconded by Trustee Bateman that the Board disallow a claim of Turner McCoy for \$129.32 until further evidence is presented that it is an obligation of the college. The motion carried.

Trustee Kendall made a motion which was seconded by Trustee Elton that President Irby notify Mr. and Mrs. Jo Frauenthal that due to financial conditions of the college it is impossible at this time to purchase the 14 lots about the President's Home now owned by Colonel McAlister. The motion carried.

Trustee Kendall made a motion which was seconded by Trustee McKinney that President Irby arrange for bids for the sale of the old heat plant located on the campus of the college. The motion carried.

Trustee Cox made a motion which was seconded by Trustee Kendall that the Board adopt the policy of retiring all members of the instructional staff who reach or have reached the age of sixty-five, or who are unable to perform their duties due to physical disabilities, and to give such people a three year leave of absence, without pay, if they so request. The motion carried.

The Board adjourned at 12:30 for lunch at the McGehee Hotel.

The Board reassembled after lunch and Chairman Bachelor directed that the order of business be resumed.

After a discussion of the athletic situation Trustee Kendall made a motion which was seconded by Trustee Cox that the college pay for uniforms up to \$1100.00 if the uniforms can be secured in addition to the amount budgeted for athletics, 1942-43. If the uniforms cannot be secured the \$1100.00 is not to go into the athletic budget. The motion carried.

Trustee Kendall made a motion which was seconded by Trustee Cox that the Board reject the boiler insurance written by Bahner Company in as much as he had not been authorized to write such policy, and that boiler insurance be left to the discretion of Chairman Bachelor and President Irby. The motion carried.

Trustee Elton made a motion which was seconded by Trustee McKinney that the salary of Connie Lee Springer be increased to \$125.00 per month beginning September 1, 1942 and the assignment of her duties be left to President Irby. The motion carried.

Trustee Kendall made a motion which was seconded by Trustee McKinney that Mr. Dan Estes be made Dean of Men instead of acting Dean of Men, to be effective May 9, 1942. The motion carried.

After a complete discussion of budget and personnel for 1942-43, Trustee Kendall made a motion that the following budget be approved and that the following named persons be employed for the positions indicated and at the monthly salary indicated; that all contracts for 1942-43 scholastic year terminate June 30, 1943, and that although the Board will make every effort to pay all salaries in full, it cannot guarantee the payment of the June 1943 salary to any person in the employ of the college. Trustee Cox seconded the motion which carried unanimously.
