### C. Organization and Duties of the Board – Board Policy No. 200

Board Policy No. 200, Organization and Duties of the Board, has proposed language revisions, deletions and additions to amend the order of Board meetings and procedures.

Therefore, the president recommends to the Board of Trustees the following resolution:

**“BE IT RESOLVED: That the Board of Trustees approves the following revisions to Board Policy No. 200, Organization and Duties of the Board, as attached to this resolution.”**

Policy Number: 200

Subject: Organization and Duties of the Board of Trustees

Date Adopted: 06/69 Revised: 09/76, 11/93, 08/11, 12/11, 02/14

---

Organization and Scope

The University of Central Arkansas forms a single-administrative unit and, pursuant to Arkansas law, is a body politic and corporate.

The Board of Trustees has seven members. Each member is appointed by the Governor, by and with the advice and consent of the Senate. Each member of the Board serves for seven years beginning on January 15 and ending January 14 of the final year. Within 10 days following an appointment, the Secretary of State must furnish a certificate to the Board member, who then has 30 days to notify the Governor and Secretary of State in writing of acceptance of the appointment. One member's term expires each year. The Board elects its chair, vice-chair, and secretary.

There is no geographical limitation within Arkansas on the selection of Board members since the University was created to serve the entire state. A Board member must be an Arkansas resident.

Organizational Meeting

The Board of Trustees at its last regular meeting during a calendar year shall organize by the election of a chair, vice-chair, and secretary from among its members, each of whom shall serve for a term of one year, or until a successor is elected. The term of office for each officer shall begin on the first day of the subsequent calendar year.

It shall be necessary to have a quorum of the Board present at any meeting for the election of officers, or for any other action by the Board, unless otherwise specified by law or in these policies.

Duties of Board Officers

1. The chair shall preside at all meetings, shall decide questions of order in accordance with Robert's Rules of Order Revised, and shall appoint all committees unless otherwise directed by the Board. The chair shall have the right, as other members of the Board, to discuss and to vote on all questions.

2. The chair shall call a special meeting of the Board whenever required conditions have been met.
3. In the absence or incapacity of the chair, the vice-chair shall perform the duties and have the obligations of the chair.
4. The secretary of the Board shall keep a record of the proceedings (this may be done by an assistant to the president of the University).
5. The secretary of the Board, **or assistant to the president**, shall furnish each trustee and the president of the University a copy of the minutes of each regular or special meeting prior to the next meeting of the Board.
6. No member of the Board of Trustees, by virtue of said office, may exercise administrative responsibility with respect to the University.

#### Powers and Duties of the Board of Trustees

The Board of Trustees is charged with the management and control of the University of Central Arkansas. The Board shall provide a university program and establish general policies in keeping with the best interests of the University and the requirements of the state law. Members of the Board shall have authority only when acting as a Board legally in session. The Board shall not be bound in any way by any statement or action on the part of any individual Board member except when such statement or action is in pursuance of specific instructions of the Board.

The responsibilities of the Board of Trustees shall be:

1. To select the president of the University and support the president in the discharge of his/her duties;
2. To elect members of the faculty and staff and ~~fix~~ **set** their salaries upon nomination and recommendation of the president;
3. To prescribe the course of study for the University;
4. To grant diplomas and degrees;
5. To consider and act on policies for the University program. Such policies may be initiated by the president, or that person or persons charged by the president with this responsibility. Any policy must be submitted for the president's consideration and recommendation;
6. To evaluate the reports of the president concerning the progress of the University program and finances;

7. To adopt or revise an annual **university** operating ~~university~~-budget as recommended by the president;
8. To contract and be contracted with; to own, purchase, sell, and convey all types of property; to accept gifts;
9. To make lawful bylaws, rules and orders as they deem necessary for themselves, all officers and employees of the University, and all persons in the University, and regarding limitations as to the number of pupils to be admitted;
10. ~~To make binding any business transacted by conference telephone calls when a majority of the Board is thereby contacted. Such business to be brought before the Board at its next meeting and said action confirmed by motion duly made and seconded.~~
10. To determine the conditions under which students shall be admitted to the University, subject to statutory limitations;
11. To ~~fix~~ **regulate matriculation and set tuition and other fees.** ~~the rate of tuition, and to fix and regulate matriculation, library, laboratory, and other incidental fees.~~
12. To exercise the power of eminent domain, subject to statutory limitations;
13. To issue negotiable interest-bearing notes or bonds, subject to statutory limitations; **and**
14. To perform the specific duties imposed upon the Board by Statutes.

### Committee of the Whole

Except as hereinafter noted, committee work shall be performed by the members of the Board sitting as a Committee of the Whole.

### Special Committees

Special committees may be created by the Board for special assignments. When so created, such committees shall terminate upon completing their assignments, or such committees may be terminated by a vote of the Board.

### Meetings

#### 1. Regular Meetings

All regular meetings of the Board of Trustees shall be held quarterly unless otherwise specified. There should be one regular meeting of the Board each year, held within 30 days after the close of commencement week (A.C.A. 6-67-102[g][1][A]). ~~Board meetings shall be open to the public except when the Board has under consideration the employment, discharge, or investigation of an individual.~~

## 2. Special Meetings

Special meetings of the Board of Trustees shall be called by the chair of the Board at the request of the president or any two members of the Board of Trustees. No business shall be transacted at any special meeting of the Board, which does not come within the purpose or purposes set forth in the call for the meeting unless all members are present and agree to consideration of the additional items. A written notice must be given seven days prior to the called meeting, or in the case of an emergency, three days notice will suffice.

## 3. Notice and Conduct of Meetings

Notice and conduct of all meetings of the Board of Trustees shall **be in accordance** and comply **with Arkansas law, specifically including** the provisions of the Arkansas Freedom of Information Act.

## 4. Quorum

A majority of the Board shall constitute a quorum for the transaction of business.

The order of business at a regular meeting of the Board of Trustees shall be:

- b. Roll Call
- c. Minutes
- d. Reports
- e. **Correspondence Action Items**
- f. **Business Notifications/Deletions**
  - i. ~~Old~~
  - ii. ~~New~~
- g. **Adjournment-Executive Session**
- h. **Adjournment**

## 6. Minutes

The official minutes of the Board of Trustees shall be kept in the Office of the President.

## Board Legislation

1. The Board of Trustees is the policy-making body of the University, and it acts with the advice and assistance of the president of the University.

2. Any amendment of these policies shall require the affirmative vote of at least four members of the Board at a regular meeting or at a special meeting, in the call for which the purpose of considering change has been announced.
3. The administration of these policies shall be the duty of the president. Any appeal to the Board of Trustees from such administration will be to the Board as a legislative body rather than as an executive body.
4. The president shall report to the Board as a legislative body from time to time on the operation of these policies and shall be expected to propose any necessary changes.

#### Board Agenda

An agenda for each regular meeting of the Board shall be prepared by the president and submitted to the Board of Trustees.

**D. Reimbursement of Expenses for Official Board of Trustees Duties – Board Policy No. 211**

Arkansas Code Annotated 25-16-901 et. seq, provides that boards and commissions may, during their first regularly scheduled meeting of each calendar year, authorize expense reimbursement for each Board member for performing official Board duties. The law states that the expense reimbursement must not exceed the rate established by state travel regulations for state employees. The law covers expense reimbursement for all Board functions. This action is consistent with Board Policy No. 211, Reimbursement of Expenses for Official Board of Trustees Duties, and Arkansas Code Annotated 6-67-102.

Therefore, the president recommends to the Board of Trustees the following resolution:

**“BE IT RESOLVED: That the Board of Trustees approves the following statement concerning reimbursement of expenses for official Board duties for 2014:**

**The UCA Board of Trustees authorizes reimbursement of expenses for each of its Board members for performance of official Board duties, to include attendance at Board meetings, fulfillment of Board training requirements, and any other official Board duties. The expense reimbursement authorized herein must not exceed the rate established by state travel regulations for state employees, including special travel authorization. The Board also authorizes the president to approve the reimbursement of travel expenses of Board members that are in conformance with this policy.”**

### **F. Waiver Requests, Act 747 of 2011: Baccalaureate Programs Requiring More than 120 Semester Credit Hours**

Act 747 of 2011 provides that baccalaureate programs may provide no more than 120 semester credit hours unless (1) a waiver has been approved by the institution's board of trustees and the Arkansas Higher Education Coordinating Board; or (2) the greater number of hours is a requirement of an independent licensing or accrediting body.

The following programs have requested waivers:

*Program name:* BS, Radiologic Technology (Radiography)

*Former semester hour requirement:* 124

*Proposed semester hour requirement:* 121

*Justification:* This program is delivered by UCA in partnership with two hospital affiliates – the St. Vincent School of Radiologic Technology and Baptist Health Schools Little Rock. US Department of Education rules for such relationships require that UCA teach more than 50% of the credit hours required in the program. The professional curriculum delivered by the hospitals requires 60 semester credit hours, a requirement established by professional programs' accreditors. Therefore, UCA must teach at least 61 semester credit hours in the program, bringing the total required hours to 121.

*Program name:* BSE, Middle Level Education

*Former semester hour requirement:* 131 (option in Language Arts and Social Studies), 132 (option in Mathematics and Science)

*Proposed semester hour requirement:* 121 (options in Language Arts and Mathematics, Language Arts and Science, Language Arts and Social Studies, Mathematics and Social Studies, Science and Social Studies), 122 (option in Mathematics and Science)

*Justification:* The proposed semester hour requirements represent a significant reduction in required hours arrived at in the process of reconfiguring the degree to allow greater flexibility to students in the options available to them in the program. Meeting all the standards required for licensure and by UCA's teacher education accreditor – Council for the Accreditation of Educator Preparation (CAEP) – means, however, that the program exceeds the 120-hour limit.

*Program name:* BSE, Elementary Education K-6 (a reconfiguration of the current Early Childhood Education P-4 program to align with the new Arkansas licensure area)

*Former semester hour requirement:* 128

*Proposed semester hour requirement:* 123

*Justification:* The Early Childhood Education P-4 program has been reconfigured in response to a change in Arkansas licensure areas. New competencies include, most significantly, a substantial new focus on the content areas of language arts/reading, mathematics, science, and social studies. Additionally, the reconfigured program adds two grade levels (fifth and sixth) to its coverage. These factors limit the reduction of hours possible in response to Act 747 and result in this request for a waiver.

Supporting documents – An ADHE Letter of Notification - 11R for each requested waiver – is provided on the pages following the resolution below.

If the Board of Trustees approves these waiver requests, the programs will be noted in Board Policy No. 321, Maximum Number of Credit Hours – Baccalaureate and Associate Degrees, as required by that policy.

All appropriate university councils and administrators have recommended approval of these waiver requests.

Therefore, the president recommends to the Board of Trustees the following resolution:

**“BE IT RESOLVED: That the Board of Trustees hereby approves Act 747 waiver requests for the BS in Radiologic Technology, the BSE in Middle Level Education, and the BSE in Elementary Education K-6.”**

The professional curriculum delivered by the hospitals requires 60 semester credit hours, a requirement established by the professional programs' accreditor. Therefore, UCA must teach at least 61 semester credit hours in the program, bringing the total required hours to 121.

### **G. Use of Skateboards and any Other Wheeled Devices – Board Policy No. 423**

Board Policy No. 423, Use of Skateboards and any Other Wheeled Devices, was adopted in 1993, and in general, prohibits skateboards and other wheeled devices on university property, with some limited exceptions. While the policy was modified in 2013, the students and others on campus asked that the policy be reviewed and made clearer.

After review by the University Police Department and Division of Student Services, and working with the Student Government Association, changes are proposed to this policy.

First, definitions are proposed for different devices. Second, the proposed policy allows these devices on sidewalks or other improved surfaces (not roadways or parking lots) provided that pedestrians have the right-of-way. These devices may not be used in cross walks. The current prohibition on using them in any university building is continued.

The proposed changes will alleviate confusion over the scope of the existing policy and the devices it covers.

Therefore, the president recommends to the Board of Trustees the following resolution:

**“BE IT RESOLVED: That the Board of Trustees approves the following revisions to Board Policy No. 423, Use of Skateboards and any Other Wheeled Devices, as attached to this resolution.”**

Subject: Use of Roller Skates, Rollerblades, Skateboards and any Other Wheeled Coasting Devices

---

The University of Central Arkansas designates limited areas for the use of skateboards, roller skates, roller blades, or any other similar wheeled devices. Except as provided below, no person may use skateboards, roller skates, roller blades or any other similar wheeled devices in or on any university buildings, sidewalks, roadways, or parking areas on university owned properties, except as specifically authorized in writing in advance by the president or president's designee. This policy shall be enforced by the university police department.

1. **Designated areas:** skateboards, roller skates, roller blades, or any other similar wheeled devices may be used on sidewalks and walkways, provided that at the time of the use the activity does not create a safety hazard or otherwise interfere with pedestrian traffic and, provided further, that skateboards, roller skates, roller blades or any other similar wheeled devices may not be used within 50 feet of any university owned building, residence hall, or other structure.
2. **Prohibited areas:** as guidance in the interpretation of this policy, the following prohibited areas are expressly noted: skateboards, roller skates, roller blades or any other similar wheeled devices may not be used in the following university owned locations: (a) inside any buildings or other enclosed facilities; (b) on stairs, steps, curbs, benches, ledges, loading docks, ramps for disabled, and any other similar fixed location, designated purpose external sites; (c) on any streets or in any parking lots occupied by vehicles; (d) any location within 50 feet of Torreyson Library; (e) in all areas and ramps immediately adjacent to the Farris Center; and (f) in all areas within and adjacent to Estes Stadium, including the track.

**1. DEFINITIONS:**

For purposes of this policy, the following definitions shall apply:

- a. Roller skate: A shoe or attachment for a shoe, with a set of wheels connected for skating.
- b. Rollerblade: A type of roller skate with in-line wheels.
- c. Scooter: A narrow platform mounted on in-line or skate-type wheels with a handle to allow steering by turning the front wheels.
- d. Skateboard: A board mounted on skate-type wheels.

- e. Acrobatics, recreational use: any action on roller-equipped devices that is not necessary for the safe forward movement of the rider and which might be described as a “trick” or “routine,” including, but not limited to, such maneuvers as having all wheels off the ground at the same time, jumping up or down steps, and similar activity.

## **2. POLICY:**

Roller skates, rollerblades, scooters, skateboards and other coasting devices are not vehicles, and are prohibited on roadways dedicated solely to vehicular traffic and in parking lots. Coasting devices are approved for use as transportation on university property, but cannot be used in any manner that places pedestrians at risk; their use for acrobatic, racing or other stunts is strictly prohibited. Persons may coast or ride upon any sidewalk or improved surface used for pedestrian purposes, provided they yield the right-of-way to pedestrians on foot, and they must be walked in crosswalks, which are often filled with pedestrians.

The use of coasting devices is prohibited within any building on the UCA campus or on any surface features (e.g., handicapped ramps, benches, or other architectural features) that might reasonably be expected to incur damage because of such use. Persons using roller skates or rollerblades must remove them before entering all university buildings.

These regulations are effective immediately and will be enforced by the UCA Police Department. Students or employees violating these regulations are subject to citation and/or disciplinary action by the appropriate university office or official. Any other person violating these prohibitions may be cited for criminal trespass as well as other appropriate criminal citation.

## **3. NOTE:**

Riding roller skates, rollerblades, or skateboards on campus grounds is good exercise and provides transportation to the rider. However, it also carries with it responsibility and liability. Accidental collisions may seriously injure pedestrians or other skaters. A person riding roller skates or skateboards who strikes anyone is liable for all medical expenses of that victim and any damage done to the victim’s property.

### **H. Smoking and Tobacco-Use – Board Policy No. 519**

Act 734 of the 2009 Arkansas General Assembly (codified as Ark. Code Annotated Section 6-60-804) prohibited smoking on the campus of institutions of higher education in Arkansas effective August 1, 2010. Prior to this legislative change, the University had a policy prohibiting smoking within 25 feet of the entrances of university buildings, but did not prohibit smoking on campus.

In November 2009, the University amended Board Policy No. 519, Smoking and Tobacco-Use. This change prohibited the "use of any tobacco products" on campus or in any vehicle owned or leased by the University.

Recently, there have been questions about the use of electronic cigarettes, and whether or not such devices should also fall with the ban of Policy No. 519. A task force was formed, under the leadership of Dr. Randy Pastor, and they concluded that electronic cigarettes should be banned from the campus and University vehicles, the same as tobacco products. A copy of the task force's report to President Courtway is attached.

Therefore, the president recommends to the Board of Trustees the following resolution:

**“BE IT RESOLVED: That the Board of Trustees approves the following revisions to Board Policy No. 519, Smoking and Tobacco-Use, as attached to this resolution.”**

The use of any tobacco products **and electronic cigarettes** is prohibited everywhere on campus and in any vehicle owned or leased by the University.

The electronic cigarette committee met on November 6<sup>th</sup> 2013 and formulated an opinion regarding the use of “e-cigarettes” on UCA’s campus.

Although the immediate effects on humans of direct or secondhand nicotine vapors emitted by electronic cigarette devices are presently unknown, there is a large concern by the medical community, and other regulating agencies, about the long-term effects of these devices on human health. It is probably for this reason that the Arkansas Senate in their 89th General Assembly approved Act 1099 in April 2013 which amended Arkansas code 6–21–609. This Act prohibits the use of these devices on public school property. Although the exact wording in this amendment appears to be primarily addressing public grade schools and secondary schools, we are aware of two Arkansas public universities that have added wording to their existing policies to prohibit the use of electronic cigarettes on their university property

Also, the US Food and Drug Administration was set to decide last month whether to lump e-cigarettes with conventional tobacco products as part of its oversight of the \$90 billion U.S. tobacco market. This ruling is still pending, probably due to the recent federal government shutdown, but there is strong evidence to suggest that such ruling will pass. If it does, electronic cigarette devices will probably be considered as a “tobacco product” and could therefore be subject to the same restrictions as all other tobacco products.

With this information available for our discussion, and also considering the concerns of the UCA student body, as represented by a member of the UCA Student Government Association, it is this committee's recommendation that UCA modify its existing policy to prohibit the use of electronic nicotine devices, commonly known as “e-cigarettes” or “vaping”, in the same way that it prohibits the use of all tobacco products on campus.

**Undergraduate and Graduate Registration Discount Program**

As referenced in IRC Sections 117(d) and 127, UCA has established a tuition remission program for eligible employees and their spouses and dependents. The purpose of this policy is to provide guidelines for use of the fee discount program. Registration discounts are designed to support the professional educational development of UCA employees and to provide an additional opportunity for the spouses and dependents of UCA employees to attain their individual educational goals.

Costs and eligibility will be based upon the registration fee schedule in place for the semester in which the initial enrollment occurs, subject to any overall registration guides or changes adopted by the Board of Trustees. The discount on required fees applies only to the facility fee, co-op fee, Student Center fee, HPER fee, athletic fee, technology fee and Fine and Performing Arts fee. The discount will not apply to any future student-initiated fees. The discount may not be used in conjunction with other University fee reductions or discounts or with other University-sponsored tuition scholarships. The discount will not apply to study-abroad programs. However, the fee-waiver discount may be used in conjunction with state-funded scholarships (ADHE-administered scholarships) and/or with private scholarships and assistance

**Eligibility and Restrictions**

Only courses taken for college credit qualify for the discount.

Eligibility is restricted to full-time, benefits-eligible employees and the spouses and dependent children of those employees. This includes benefits-eligible employees and his/her spouse and dependent children where the employee is regarded as benefits-eligible for the purposes of this policy and paid from outside funding sources (e.g. Military Science). Members of the Board of Trustees, their spouses and dependent children are not eligible for the fee waiver.

The fee remission for employees, spouses, and dependent children will commence with the beginning of the next semester or term after the date of employment. For example, if an employee's hire date is October 1, their fee-remission privileges will begin at the start of the spring semester.

## **Employees**

During normally-assigned work hours, employees may take no more than six (6) credit hours in the fall and/or spring semesters and no more than three (3) credit hours during each summer term.

The first three (3) credit hours taken during assigned work hours will not require any leave time. If the employee so chooses, the employee may, during the fall and spring semesters, take an additional class of up to three (3) credit hours during his/her lunch period. Time-off for courses taken during normal work hours, including the lunch period, must be approved by the employee's supervisor and department manager. Efforts should be made to schedule courses at times that will least interfere with heavy seasonal work-loads or exceptionally busy periods of the work day.

## **Children**

Children are defined as the unmarried children of benefits-eligible employees or the unmarried dependents for whom the employee is the legal guardian, who are under age 25 and who may be claimed as dependents for federal tax purposes by that employee. An employee may receive a fee waiver for a child meeting the aforementioned definition of children through and including the semester in which the child turns age 25.

## **Costs**

Employees, the spouses of employees, and/or the children of employees will pay an amount equal to twenty (20) percent of regular in-state registration and applicable eligible fees for undergraduate courses.

Employees will pay an amount equal to twenty (20) percent of the regular in-state registration and applicable eligible fees for graduate courses.

Graduate degree fee discounts are not available for spouses or children.

If an employee resigns or otherwise moves from benefits-eligible employment during a semester in which the employee, spouse and/or dependent discount is used, the employee must pay a prorated portion of the regular registration and fees represented by the period of time remaining in that semester.

## **Exceptions**

If an employee dies or becomes disabled (as determined by the University's disability insurer) during a semester in which the employee, a spouse or dependent is receiving the discount, the disabled employee and/or the surviving spouse and/or dependent will continue their eligibility as if that employee was still eligible and with all other guidelines and restrictions remaining. Spouses and dependents who are not receiving the discount at the time of the employee's death or disability will be eligible for the discount for five (5) years from the date of death or disability.

**SUMMARY**

1. Parties: Agreement between the University of Central Arkansas and Aramark Educational Services, LLC (“Aramark”).

3. Term: The Board of Trustees approved the original contract in April 2012. The contract was effective June 1, 2012, and is renewable for up to 10 years. The Board approved revisions in May 2013.
4. University Funds to be paid: Under the terms of the contract, Aramark and UCA mutually agree upon an appropriate increase to the board plan rates, utilizing the most recent twelve-month increases in the Consumer Price Index for All Urban Consumers (CPI-U). If the indices are equal to or greater than 3.0%, Aramark is entitled to a minimum board plan rate increase of 3.5%. The December 2013 CPI-U was only 2.1%; therefore, the proposed agreed upon rate increase is 2.35%. The increases are reflected in the attached schedule.
5. Funds Received: No revisions.
6. Public Bid/Purchasing Approval: N/A.
7. Special Provisions/Terms/Conditions: The administration and Aramark are proposing a change to the contract regarding annual board plan increases for the remainder of the contract. Aramark and UCA shall utilize as a guideline the most recent October increases in the CPI-U to determine increases in board plan rates. The proposed change allows Aramark and UCA to begin discussions on board plan rates using the October CPI-U received in November each year rather than the current format of using the December CPI-U received in January.

**SUMMARY**

### **K. Fees – Room and Board – Board Policy No. 632**

The current room and board rate is \$2,765.00 per semester (based on a double-occupancy room and the total access meal plan with \$50 DCB).

A 4.51% increase is recommended for the board plans to cover the proposed 2.35% increase in the Aramark contract and to further supplement food service revenue. The estimated net food service revenue generated from this increase is approximately \$208,000 per year. The Department of Housing and Residence Life completed a review of board plan rates from public institutions within the state, as well as those within the Southland Conference. The proposed 2014-15 board plan rates still place UCA near the bottom of the price range for both the Arkansas universities and the Southland Conference.

A 4.50% increase is recommended for room rates. This increase is primarily related to the continuing effort to maintain and upgrade housing facilities and to cover a 35% increase in the cable television rate for the University. Recommended repairs to the residence halls and university-owned apartments exceed \$18 million. Estimated net annual revenue generated from the proposed increase for the housing room rates is \$435,000. The Department of Housing and Residence Life's review of room rates placed the proposed 2014-15 room rates at the mid-point price range of the rates of other universities for 2014.

The proposed room and board rate for 2014-15 is \$2,889.00 (based on double-occupancy room and the total access meal plan with \$50 DCB), for an overall increase of 4.48%. This increase will result in the student paying an additional \$124 per semester.

For the 2014-15 academic year, the Department of Housing and Residence Life anticipates an annualized occupancy rate of approximately 95%. Housing applications with paid deposits submitted to date for fall 2014 are up by 180 compared to the number of applications received this time last year.

Therefore, the president recommends to the Board of Trustees the following resolution:

### M. Undergraduate Admission Standards for Traditional Students

UCA's initiatives to increase retention and graduation rates include plans to raise admission standards for traditional undergraduate students. In this context, "traditional student" refers to a student under 21 years of age who is a U.S. citizen or a resident alien.

The proposed changes to the admission requirements will continue to require students to earn a minimum score of 19 on the ACT or equivalent in each subject area (English, math, and reading) for unconditional admission. Traditional, new, first-time students who do not meet minimum score requirements in these subject areas must begin to satisfy their remediation by enrolling in transitional courses during the first and every subsequent semester until these requirements are completed. All transitional coursework must be completed within the first 30 hours of enrollment.

The attached proposed admission standards are expected to achieve the following results:

- Increase the academic quality of the student population;
- Increase retention and graduation rates; and
- Align UCA's admission standards with other four-year, public institutions in Arkansas.

The University Admissions Committee and all appropriate administrators have recommended approval of the proposed admission standards.

Therefore, the president recommends to the Board of Trustees the following resolution:

**“BE IT RESOLVED: That the Board of Trustees hereby approves the proposed admission standards as attached to this resolution.”**

**Proposed Undergraduate Admission Standards for Traditional Students**

UCA makes admission decisions based upon sixth-semester high school grade point average and ACT/SAT scores. Below is a comparison of current admission requirements and proposed incremental changes to admission requirements.

**Fall 2015**

Beginning fall 2015, the administration recommends increasing high school grade point averages and standardized test scores for unconditional and conditional admission.

### **O. Lewis Science Center Addition and Roof Replacement**

The administration is requesting that the Board of Trustees grant authority to proceed with a feasibility study for a bond issue to fund the design and construction of “Lewis Science Addition”; proceed with the design and construction of the addition; increase the Facility Fee by \$3.50; proceed with the replacement of the Lewis Science Center roof; and, amend the existing contract with Stuck Associates.

The Lewis Science Center was designed in 1965 as a 53,000 square foot, single story, flat roof structure. A 62,000 square foot, two-story addition to the north side of the structure was added in 1987.

Although the facility is sound structurally, significant repairs are needed, additional classroom space is required to meet the current student demand, and the laboratory and research space is inadequate and out-of-date. Needed repairs include the addition of fire walls, asbestos abatement, mechanical system replacement, building code upgrades, roof replacement, accessibility upgrades and complete replacement of the 1965 electrical system.

In 2013, the University retained Stuck Associates, WER Architects and RFD Lab Consultants to provide a full building assessment of the existing facility. They were charged with providing preliminary recommendations based on programmatic and space needs for future building requirements for the College of Natural Sciences and Mathematics (CNSM). The team prepared a report in December 2013 titled the *Lewis Science Center Assessment*.

The design group Stuck Associates, WER along with RFD Lab Consultants, met with the CNSM faculty and others on the concept of the project. Based on discussions and projections of the University’s available funding, the architects recommend (1) the construction of a new building of approximately 50,000 square feet adjacent to Lewis Science Center and (2) a subsequent renovation of Lewis Science Center.

At its December 2013 meeting, the Board reviewed the *Lewis Science Center Assessment* detailing the challenges of the existing facility, the preliminary design of the addition, and how these changes will meet the needs of the University within the proposed budget of \$25.5 million for new construction and renovation. The Board also reviewed the placement option for the addition as provided by Stuck Associates, WER.

This action covers the Lewis Science Center addition with an anticipated cost of \$17.5 million. Existing University Capital Reserves of \$4 million have been designated for this project leaving an amount to be bonded of \$13.5 million.

The proposed 50,000 square foot, three-story addition will include teaching, learning and research space allowing flexibility to meet the modern teaching methods. The laboratory spaces will allow for proper floor to ceiling heights required for modern equipment and

modern utilities. Also included in the design will be features allowing for significant improvements in equipment efficiency and utility utilization with LEED certification in mind.

The addition is anticipated to cost approximately \$17.5 million, including construction, architecture and engineering fees, utility work, infrastructure, furnishings and fixtures, and a contingency. Only \$13.5 million will be bonded. The proceeds of the bonds, if approved by the Arkansas Higher Education Coordinating Board (“Coordinating Board”) and then by UCA’s Board of Trustees, will be used to fund the project.

The debt service will be repaid from educational and general funds based on a proposed student facility fee increase of \$3.50 per credit hour which equates to a 1.38% increase. A student taking 15 hours will pay an additional \$52 per semester.

The Coordinating Board’s policy states educational and general projects (E&G) may be financed by obligating a maximum of 25 percent of **net** student tuition and fee revenue (**gross tuition and fees less unrestricted educational and general scholarship expenditures**) for total debt service.

The above data demonstrates that the University has sufficient revenue to support E&G debt of approximately \$13.5 million with a term of 30 years at an estimated annual interest rate not to exceed 5.75%.

In accordance with the Coordinating Board’s policy, the University will establish and maintain a building maintenance fund to be supported by student tuition and fee revenue. The institution will reserve a minimum of \$2.50 per square foot of the addition, annually, for ongoing maintenance issues. This annual transfer of \$125,000, based on the square feet of the addition will be held in Plant Funds’ Repair and Replacement Fund.

If approved by the Coordinating Board, another resolution will be presented to the Board of Trustees at a future meeting to authorize the issuance of the bonds.

Prior to construction beginning on the Lewis Science Center Addition, it is necessary to remove and replace the existing roof of the Lewis Science Center in order to protect the interior of the building. The roof is at the end of its useful life as a result of numerous patches over the years to prevent leaks.

The roof is anticipated to cost \$750,000. This project is the number one priority on the university's E&G deferred maintenance list; however, the project was put on hold because of the ongoing assessment of the Lewis Science Center project. Although the cost is undetermined at this time, additional funds will be needed for damage remediation caused by the long standing water infiltration. This project will be funded from the University Capital Reserves Account.

The project will require a Method of Financing (MOF) to be considered by the Arkansas Legislative Council and the Department of Finance and Administration. The design work will be performed by Stuck Associates, however, their contract will need to be amended beyond the Phase I assessment. On August 16, 2013, the Board approved the original Stuck Associates contract in order to undertake a comprehensive review and analysis of Lewis Science Center to determine its condition and to establish whether the space can be designed and renovated to accommodate the natural sciences programs. The existing contract with Stuck Associates will need to be increased to \$1,596,129 in order for the firm to provide architectural and engineering services for the construction of the Lewis Science Center addition and the replacement of the Lewis Science Center roof. The original contract amount was \$189,700.

The roof project will be bid and a contract will be submitted to the Board for approval. The roof project is scheduled to begin in mid-May and be completed in mid-August 2014.

The preliminary timeline for the new construction phase is set forth below:

January 2017	Classes begin in new building

Therefore, the president recommends the following resolutions to the Board of Trustees:

**“BE IT RESOLVED: That the Board of Trustees authorizes the administration to (1) proceed with the planning, design and construction of an addition to the Lewis Science Center containing approximately 50,000 square feet with an estimated cost of \$17.5 million, (2) amend the existing contract with Stuck Associates to \$1,596,129, and (3) enter into other contracts necessary to facilitate the project.**

**BE IT FURTHER RESOLVED:** That the Board of Trustees authorizes an increase in the Facility Fee of \$3.50 to fund the debt service of the necessary bonding of \$13.5 million.

**BE IT FURTHER RESOLVED:** That the Board of Trustees approves the replacement of the Lewis Science Center roof, and authorizes the administration to enter into and execute any and all contracts, documents and agreements; provided however, that the total project cost shall not exceed the sum of \$750,000, unless such excess is approved by the Board of Trustees.

**BE IT FURTHER RESOLVED:** That the Board of Trustees adopts the attached resolution regarding the issuance of bonds for the Lewis Science Center Addition.”

**WHEREAS**, The University desires to secure funds in an amount not to exceed \$13.5 million by the issuance of bonds, with a term not to exceed 30 years at an interest rate not to exceed 5.75% and with a projected maximum annual debt service of \$965,250; and

**WHEREAS**, The proceeds from the bonds will be for the design and construction of an addition to the Lewis Science Center; and

**WHEREAS**, If approved and issued, the bonds will be serviced from student tuition and fees, the same being facility fee revenue from students; and

**WHEREAS**, The Board of Trustees authorizes and recommends the commencement of preparations for securing a bond issue in an aggregate principal amount not to exceed \$13,500,000 for the purposes described above.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES THAT:**

**Section 1.** The Board of Trustees of the University of Central Arkansas hereby authorizes the administration to commence all necessary preparations to issue bonds in an amount not to exceed \$13,500,000 with a term not exceeding 30 years and at an interest rate not to exceed 5.75%, with terms and conditions satisfactory to the administration, subject to final review and approval by resolution of this Board.

**Section 2.** The Board further authorizes the administration to seek approval from the Arkansas Higher Education Coordinating Board for issuing the bonds.

**Section 3.** The loan will be secured for the purpose of design and construction of an addition to the Lewis Science Center.

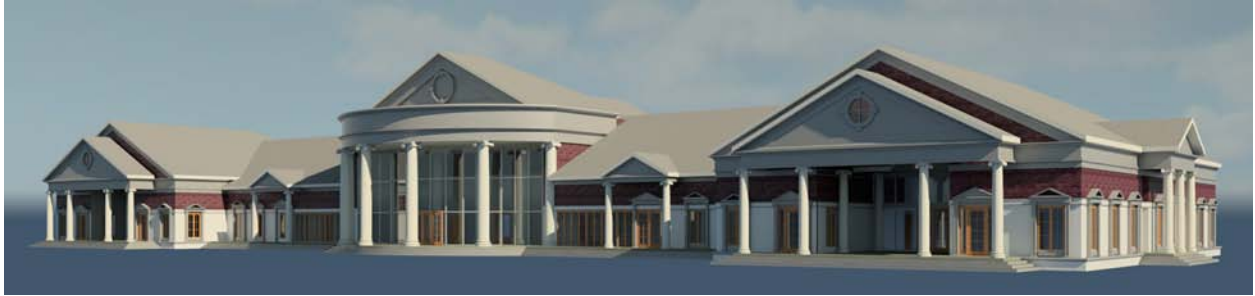

## VII. NOTIFICATION/DELETIONS

### **B. Notification: Revisions, Deletions, and Name Changes in Teacher Education Programs**

The Professional Education Unit has recommended, and the president and provost have approved, a series of revisions and deletions in teacher education programs. A summary of the changes is followed by supporting materials: (1) UCA curriculum forms for each change, (2) ADE submission forms where relevant, and (3) ADHE letters of notification for each change where relevant.

#### **(1) Changes to the BSE in Middle Level Education**

Changes have been made in the Middle Level Education licensure program to meet recent Arkansas Department of Education (ADE) curriculum changes, reduce program hours in compliance with Act 747 of 2011 (see request for a waiver in the action agenda), and align the program with new national standards in middle level education. Changes include use of the new UCA Lower-Division Core (38 hours); implementation of new courses and revision of others; allowing middle-level education students to choose any two of the four major content areas in accordance with ADE guidelines; and ensuring alignment of the program with national and state standards, especially state content competencies and InTASC standards.

#### **(2) Changes to the BSE in Early Childhood Education (P-4)**

The Early Childhood Education (P-4) program has been revised and renamed to meet the Arkansas Competencies for Elementary K-6 Teachers, Arkansas Teaching Standards (InTASC), and the Association of Childhood Education International (ACEI) Standards. The new plan of study submitted to ADE and ADHE indicates existing professional education courses from the P-4 Early Childhood Education program which were revised to meet K-6 competencies and standards, as well as new professional education courses. While every effort was made to limit credit hours as required by ACT 747, the revised K-6 program necessitates a minimum of 123 hours to meet all the required competencies and standards and to cover grades K-6. (See the Act 747 waiver request in the action agenda.)

#### **(3) Environmental Science Majors Eligible for STEM Education Minor**

The STEMteach program allows mathematics and science majors to complete the STEM Education Minor in order to add a teaching license to their respective bachelor of science degrees. The program currently specifies that eligible science majors are those earning a BS degree in chemistry, biology, physics, and general sciences. Environmental Science majors (biology and chemistry tracks) also complete sufficient coursework to be eligible for a teaching license provided that they complete the STEM Education Minor. This proposal adds the BS in Environmental Science (biology and chemistry tracks) degree to

the STEMteach program as another permitted science degree. Original proposal documents have been updated and will be resubmitted to ADE and ADHE.

**(4) BA in Modern Languages: K–12 Licensure, Teaching and Learning Minor**

Arkansas licensure in foreign language teaching is moving from P–12 to K–12, and the Department of World Languages, Literatures, and Cultures has revised its curriculum for the Modern Languages program’s tracks in French and Spanish with licensure to reflect that change. In addition, these degree tracks now use the recently approved Teaching and Learning minor to provide 20 hours of the professional education courses required for teacher licensure.

**(5) Deletion of the P–4 Track in the Master of Arts in Teaching (MAT) Program**

The P–4 Early Childhood Education track has been deleted from the MAT program as mandated by the Arkansas Department of Education because of licensure area changes. The last candidates for early childhood licensure were admitted in fall 2013.

**(6) Name Change, Office of Professional Field Services**

The Office of Professional Field Services in the College of Education has been renamed the Office of Candidate Services. This reflects current usage and better describes the range of services provided by this office to teacher education candidates.

### **C. Notification: Changes to the MS Program in School Counseling**

In response to changes in Arkansas school counseling licensing pathways, the Department of Leadership Studies and the College of Education have proposed, and the provost and president have approved, a series of changes in the university's MS program in School Counseling. These changes have been reviewed by all appropriate councils and administrators, and all have recommended adoption of the changes. Relevant supporting documents follow the summary of changes.

#### **(1) Two Track System**

The current MS program in School Counseling is a single-track program for individuals who hold a valid Arkansas teaching license and who desire to add the school counseling license to their teaching license. Recently, the Arkansas Department of Education approved new pathways for individuals to become licensed school counselors. One of the new pathways is for individuals who do not hold a teaching license and will not be required to hold such a license.

The department proposes to modify this program by creating two enrollment tracks: Track 1 will be the Add-On Licensure track for individuals who currently hold a valid Arkansas teaching license. Track 2 will be the Initial Licensure track for individuals who do not hold a valid Arkansas teaching license. This proposal will allow UCA to serve both those individuals who hold a valid teaching license and those individuals who do not hold a valid teaching license.

As currently proposed, the degree program's curriculum will remain unchanged. We are revising selected admission, retention, and graduation requirements that are unique to those who enter the Initial Licensure track in order to comply with anticipated Arkansas Department of Education regulations (see item 3, below).

#### **(2) Post-Master's Certificate (PMC) in School Counseling**

The department proposes to supplement the two-track School Counseling program with a Post-Master's Certificate (PMC) for individuals who hold appropriate graduate degrees. The Arkansas Department of Education has expanded its definition of appropriate initial licenses to which a school counseling license may be added, including speech-language pathology and school psychology. The new PMC will allow UCA to conduct transcript analysis of previous graduate degrees to ascertain specific course work that must be completed to add the school counseling license to appropriate graduate degrees. The PMC will provide an award/credential for those who do not need to complete another master's degree.

**(3) Revision of Admission, Retention, and Graduation Requirements for the MS in School Counseling**

Revised admission, retention, and graduation requirements address the changes noted above in item 1 – specifically, candidates seeking licensure as an Initial License. Documentation to be submitted to ADHE and ADE provides details of admission, retention, and graduation requirements addressing the new category. Each set of requirements (admission, retention, and graduation) is organized into two categories: Both Tracks and Initial Licensure Tracks. Under ADE rules and regulations, there are unique requirements that pertain to the Initial Licensure track.

### **D. Notification: New Language Arts Option in the MA Program in English**

Faculty of the Departments of English and Writing have proposed, and the provost and president have approved, the addition of a new Language Arts option to the existing MA program in English.

This new track in the MA program is tailored specifically to the needs of high school and other instructors looking for additional content knowledge, especially in diverse literatures and in composition, creative writing, and linguistics content. This option is *not* related to teacher licensure.

In particular, this program addresses the needs of Language Arts teachers to conform to the new common core curriculum in the state's schools. It is designed to help prospective and current teachers to become more globally literate and to develop their content knowledge in all areas of writing and language – to become true practitioners in all areas of English Language Arts. Secondary teachers and others will diversify their knowledge of global literature, learn methods of integrating diverse literatures into their curricula, gain a better understanding of current linguistic theory as it pertains to teaching literacy, and allow graduate-level study for teachers seeking a higher degree in writing pedagogy and composition theory that would allow for the implementation of the teaching of creative writing and writing across the curriculum. Students will broaden their teaching of language arts skills beyond the traditional instructional venue.

The new option requires 21 hours within the existing 30-hour degree program. In order to make the new option attractive to teachers and others who have daytime jobs, the program can mainly or wholly be taken at night and during the summers. Thus, by taking a class in each of three summer terms and a class in both the fall and spring terms of two consecutive years, a candidate could finish the program in just over two calendar years.

All appropriate councils and administrators have recommended the addition of this option to the MA in English.

**9. Reason for proposed action**

English Language Arts licensed teachers in the state of Arkansas who wish to earn a Master's degree have several options: an MA in English or in an education field such as UCA's Masters in Teaching or Reading or the Advanced Studies in Teacher Leadership (ASTL). While these options are valuable, for the teacher who wishes to increase content knowledge and skills specifically in language arts including writing and linguistics, there is no clear option; one must make a choice to concentrate in one area or the other. While the ASTL degree offers content areas in English literature or Writing, these cannot be combined, and the student must take half of the 10 required courses in educational knowledge and skills. For the teacher who wishes to develop competency in all of the language arts by focusing on content and delivery specifically of that content, there is no option. In fact, there is no degree in the state that includes all of the language arts. Although students may enroll in the University of Arkansas at Little Rock's degree in Professional & Technical Writing, the University of Arkansas's degree in Creative Writing, or UCA's own MFA in Creative Writing, none of these has any emphasis on or appeal to teachers.

The Language Arts option in the existing MA degree program in English will give secondary language arts teachers the opportunity to earn an MA in a program that will strengthen both their curriculum by including additional coursework in literature, writing, creative writing and linguistics as well as courses focused on the pedagogy of delivering writing, creative writing, literature and literacy.

However, this option is not only for teachers. The curriculum combines the study of diverse literatures, writing theory and linguistics, which provides the tools necessary for PhD level study in literature, rhetoric and composition, or Teaching English to Speakers of Other Languages (TESOL). By developing skills in critical thinking, research, and writing, students will be prepared for careers in all aspects of the writing/researching/training and education fields. Many careers support the education industry, such as education management, educational publishing, producing educational materials and media, education software development, and test development. Other paths include teaching English in settings other than the public schools (such as industry or overseas) and writing fields such as publishing, editing, and writing for publication. This degree will be ideal for students with undergraduate degrees in education who wish to use their education backgrounds and experiences in a field other than teaching in the public schools.

In order to make the new option attractive to teachers and those who have day jobs, the department proposes a program that can mainly or wholly be taken at night and during the summers. - (2) To provide other students with the tools necessary for PhD level study in literature, rhetoric and composition, or Teaching English to Speakers of Other Languages (TESOL).
- (3) To prepare still other students for careers in writing fields such as publishing, editing, and writing for publication.

**e. Expected student learning outcomes**

- (1) Demonstrate a diversified knowledge of global literature.
- (2) Master methods of integrating diverse literatures into curricula.
- (3) Understand current linguistic theory as it pertains to teaching literacy.
- (4) Master writing pedagogy and composition theory, allowing for the implementation of the teaching of creative writing and writing across the curriculum.
- (5) Attain these same masteries and understandings as applied to non-teaching careers related to the language arts.

**f. Documentation that program option meets employer needs**

The ADHE Employer Needs Survey was also sent out to over 40 Arkansas school districts. Of those returned, all said they would give preference in hiring to candidates with this degree, and they all anticipate openings for which this degree would be preferable. Community colleges and 4-year universities also prefer this Master's degree for lecturers and adjunct faculty in composition and literature classes. Salaries at the university level begin at about \$35,000 and at the public school level, at \$36,473. (For the employer survey and a summary of responses, see Appendix A.)

The Bureau of Labor Statistics publishes information that suggests that, for those not in teaching, this degree is useful in pursuing a career in writing or editing. According to *The Occupational Outlook Handbook 2010-2011*, "A bachelor's degree or higher is typically needed for a job as an author, writer, or editor. Because writing skills are essential in this occupation, many employers like to hire people with degrees in communications, journalism, or *English*" (emphasis added). (See <http://www.bls.gov/oco/ocos320.htm>.)

**g. Student demand (projected enrollment) for program option/minor**

A survey conducted by faculty of UCA English education alumni and former participants in the Writing department's summer writing project-two groups who will be likely candidates for this program, 94.9% said that salary increases were also available for a BA/BSE plus twelve additional hours, and 94.9% said that they would receive a salary increase for additional hours beyond the MA, so there is also some incentive for non-degree seeking teachers to take courses from this program. At the same time, only about 30% of the teachers surveyed indicated that their local districts helped defray tuition costs at all, which suggests that students in this program are not likely to take more than one or two courses per semester

because of cost as well as their own time constraints, and thus the program is designed to accommodate part-time students.

Most importantly, when asked whether they would be interested in pursuing this particular degree; 55% of those surveyed answered “yes” – some with great enthusiasm, like the teacher who wrote “ABSOLUTELY!!!!!!!!!!!!!! PLEASE GET THIS PROGRAM GOING!” Another 17.5% indicated that they might be interested, including the respondent who wrote that s/he might take “supplemental classes, even if I didn’t get the degree.” 22.5% of the respondents said that they were not interested in the degree, but reasons for this negative response varied. One teacher said she was saying no “only because I am so close to retirement.” Another said “Yes, if I didn’t already have an MA,” a response that suggests that some of the teachers surveyed did indeed see the proposed degree as more valuable for their job than the traditional MA. Another 5% of those surveyed indicated they were “unsure” about their interest in the program.

However, of those teachers who did not already have a Master’s degree, 79% indicated that yes, they were interested in this newly proposed degree. 21% said that they were possibly interested. No respondents in this category indicated that they were not interested. Even those already possessing Masters’ degrees showed some interest in the program, with 33% indicating they would be interested in at least taking the classes involved. 38% of teachers with Masters’ degrees said they were not interested, while 14% said they might be interested. 4.7% of the respondents with Masters’ degrees said they were “unsure,” while 9.5% said “not at this time.”

Based on these numbers, and assuming that the 43 respondents to the survey are a representative sample, we believe we will have a significant pool of candidates from which to draw initially. (For the student survey and a summary of responses, see Appendix B.)
