Pursuant to a call by the chairman the Board of Trustees of the State Teachers College met at 2 o'clock P M, Saturday, October 3, in the office of the Superintendent of Public Instruction with the following members present:

The president of the college made recommendations as follows:

Lowell Thompson to be a member of the college faculty as teacher of history and other subjects at the salary of two thousand (\$2000) dollars a year, the term to begin September first, 1925.

The salary of GY Short, assistant registrar, to be raised twenty five (\$25) dollars a month, beginning October first, 1925, raising his salary from one hundred and seventy five (\$175) dollars a month to two hundred (\$200) dollars a month.

Mrs. E. L. Higgins to be temporary assistant in English at the salary of fifty (\$50) dollars a month, the term to begin September 21, 1925.

Mrs. H F Hess to be temporary assistant in the foreign language department at the salary of fifty (\$50) dollars a month, the term to begin September 21, 1925.

Joe Russell to be continued as clerk in the Registrar's office at the salary of forty (\$40) dollars a month.


William Cordrey to be temporary laboratory assistant at the salary of fifty (\$50) dollars a month, the term to begin September 21, 1925.

These recommendations were all approved.

The president filed also statements as to the condition of the salary fund, the library fund, the incidental fund and the athletic fund.
