A resolution was offered by Trustee Smith with a motion that it be adopted, seconded by Trustee Compere and on the call of the roll at the direction of the Chairman the following voted in favor thereof, to-wit: Phipps, Page, Andrews, Compere, Parker, Smith.

Said vote being in favor of the adoption thereof, the Chairman declared that the Board of Trustees had duly adopted said resolution which is as follows, to-wit:

BE IT RESOLVED by the Board of Trustees of the Arkansas State Teachers' College, Conway, Arkansas, that, subject to the approval of the Federal Emergency Administration of Public Works, the award to be made to low bidders for the finish hardware, auditorium seating, and furniture, and equipment in connection with PWA Docket No. Ark. 1092-R, as follows:

Finish Hardware for all buildings to be constructed under above named docket - Krebs Brothers Supply Company, Little Rock, Arkansas, on their bid of \$4,531.00.

Furniture and equipment for Science Building (Group Bids B, D, and E. Bid B, \$15,757.31. Bid D \$1,054.18. Bid E, \$3,299.01). E. H. Sheldon Company of Muskegon, Michigan (Total of these groups \$20,110.50.)

Auditorium Seating - W.E. Hinson Manufacturing Company, Fort, Smith, Arkansas, on their bid of \$4,000.00.

The Chairman and Secretary of this Board of Trustees be and they are hereby authorized and directed (subject to the approval of the Federal Emergency Administration of Public Works) to execute contracts with said low bidders in behalf of the Board of Trustees of the Arkansas State Teachers College.

BE IT FURTHER RESOLVED THAT subject to the execution of the necessary contract documents by said low bidders, the bidders and bonds of the second and third low bidders be held in reserve.
