

Little Rock Arkansas, May 13th, 1920.

On this 13th day of May, 1920, the Board of Trustees for the Arkansas State Normal School met pursuant to adjournment in the office of Honorable J.L.Bond, Superintendent of Public Instruction, with J.L.Bond, L.S.Dunaway, J.T.Frauenthal and A.L.Hutchins present.

Meeting called to order by J.L.Bond, chairman, A.L.Hutchins elected Secretary Pro Tem, and the following proceedings were had,

The salary schedule as arranged by President B.W.Torreyson for 1920 and 1921 in conformity with resolution of the board heretofore adopted was submitted, and on motion of L.S.Dunaway, seconded by Joe Frauenthal was adopted, all present voting aye.

On motion of Joe Frauenthal seconded by L.S.Dunaway the salary of President Torreyson for ensuing year was fixed at \$3,750.00, all present voting aye.

The faculty for 1920 and 1921 as recommended by President B.W.Torreyson was elected as follows,

On motion of A.L.Hutchins, seconded by Joe Frauenthal President B.W.Torreyson was authorized to take a page ad in Normal School Manual, cost not to exceed \$22.50.

Moore, Edna Nesbit, Pauline Parham, Gladys Pinson, Ruth Rushton, Coy Rogers, Mamie Schichti, Lillian Stroup, Louise Taylor, Mamie Taylor, Winnie Trantham, Ernest Vinson, Arthur Vaughn, Marie Walkup, Lillian Watson, Ethel Wood, Cora Wheeler, May Wilson, Jessie Williams and J.E.Winters.

The following expense accounts were presented, examined, allowed and ordered certified for payment, to-wit: A.L.Hutchins \$10.79, L.S.Dunaway \$4.46 and Joe Frauenthal \$2.75.

The President and faculty were authorized to proceed to add two years of college course with the understanding that there should be no increase in the teaching force or expense on account of such additional work.
