#### **Course Description**

Medicinal Biochemistry (Chem 4309) is a capstone course that integrates synthetic organic chemistry, pharmacology, and biochemisty. The processes of drug design/synthesis (Carter), consideration of drug Absorption / Distribution / Metabolism / Elimination (ADME, Kelley), specific drug mechanisms of action, and the structural / biochemical basis of the diseases they treat (Isom) will be investigated for common classes of pharmaceuticals.

#### **Prerequisites:**

The prerequisites for this course include the completion of Organic Chemistry II (Chem 3411) and Biochemistry I (Chem 4320) with a C or better.

## **Course Materials**

An Introduction to Medicinal Chemistry, Patrick, G.L. 6<sup>th</sup> ed., Oxford University Press.

For a course of this level, students should not expect the course to center around or to be able to rely on a single textbook for instruction and/or assistance. Therefore, students should be aware that the instructors will primarily rely on a variety of resources including graduate-level texts and primary scientific journal articles for information.

#### **Class Attendance and Make-up Policy**

Class attendance is strongly recommended. Those students who attend class regularly are the most likely to succeed in this course. As mentioned above, the vast majority of the material presented in this course will not be in a textbook. So attending class is necessary to obtain all the information that you will be held responsible for on guizzes and assignments. Whether a student is excused from an announced quiz or allowed to take it at a later date is solely the discretion of the instructors. If you must miss a class during which assessments are given or due, substantial proof (what constitutes this is solely our discretion) of the reason for the absence will be required before any consideration for make up work is granted. Any student who is absent from class for 4 class meetings without contacting me may be dropped from the course with a F, at my discretion

# **Class Communications**

Students are required to obtain all information missed from class absences from their peers. It is a very good idea to have a classmate record a lecture that you know you will miss. Once notes and/or lecture recording(s) have been obtained and reviewed, students should come to my office during office hours to clarify any confusion about the missed material. If a texting app service is used for the class, class announcements may be sent out by email and/or text. Students should check their UCA email account regularly for class information/reminders. Announcements may also be made using the course management system.

# **Class Disruptions**

Students are expected to be engaged and attentive during lecture and to act respectfully toward the instructor(s) and their peers throughout the duration of the class. Students who act in a disrespectful or disruptive manner (talking during lecture, sleeping in class, TEXTING OR CELL PHONE USE, intolerance for other students' questions, etc.) will be required to leave the class and will not be allowed to make up any assignments or exams missed because of the dismissal. If the behavior continues, the student will be dropped from the class by the instructor and assigned the appropriate grade. Cell phones are not allowed in the student's possession during exams and/or quizzes. Any student wishing to bring one of these devices to class during testing are required to leave the device on the desk at the front of the classroom at their own risk. The student is solely responsible for the safety of their devices if they choose to bring them into the classroom during exam times. # **Course Assignments**

# Quizzes (120 pts)

There will be four announced quizzes during the course of the semester.

## **Student Lectures (90 pts)**

Each student will select and obtain approval on one drug that must be administered orally. Building on foundational lecture material, the lecture will consist of 25 minutes (20-minute lecture and 5 minutes for questions). The presentation will need to include the synthesis of the drug, the mechanism of action and the ADME of the drug). Students will submit their lecture slides and references through Google Classroom. Students should submit their lecture materials 48 hours prior to their schedule lecture time.

## Show and Tell (40 points)

Scheduled lecture days will be available for the students to present a show-and-tell over one of the drugs covered in class. The student will be limited to two minutes with one minute allowed for questions.

# Miscellaneous Assignments (0-100 pts/per instructor)

Some additional assignments may be given throughout the semester. These may include homework or other assignments as the instructors deem appropriate. Class participation points may also be applied that reflect attendance, participation in discussions and lecture, and project involvement.

# Grading

The following is a **tentative** summary of the assessment tools used included in this class. Specific numbers may be changed if deemed necessary. Grades **will not be curved** in the traditional sense of the word. A curve involves adding points to exam grades to raise the class average to a "C". Therefore, the average grade in this course will not necessarily be a C. However, the instructors do reserve the right to adjust scores when deemed necessary.
