- Attendance was sparse
- JH pulled Argos report for all those teaching RL and sent them information on how to locate online training materials
- KB raised concern that not all those teaching RL know which goal is included in the course and/or faculty may not know they are teaching a course in the core.
- JH feels this may be a communication breakdown from chairs and/or due to simply roll out of core/assessment as our systems evolve

# Concerns/questions

- Concern/recommendation based on first reviews: Instructors weren't submitting assignment guidelines. Committee is requesting more specific, concrete assignment guidelines.
- Can a course count as capstone and content area (diversity, RL). If not, then
  recommend music remove 4102, 4108 from consideration. Core revisited idea
  that capstone cannot include RL and DIV and must focus on CI and COMM.
  Discussion. Capstone may be area of confusion of cross-disciplinary experience.
  Programs may need support looking at concept of capstone.
- Can variable credit courses count in upper division core (MUS 4VXX). If student takes 1 credit course multiple times, then would they be assessed multiple time and would/should it count for core capstone. Discussion. For categories, core guidelines stipulate 3 hours although capstone can be variable (fewer than 3 hours)
- Rationale for including class in core needs to emerge from course (not UCA or programmatic, top-down expectations).
