- I. Call to Order
- II. Assessment update: J. Held updates the Council on various issues
 - a. Diversity scoring and report
 - a.Report will be ready within a month and then the assessment sub-committee can begin its review. Drs. Held and Combs will offer campus wide forums to discuss the report as they did last year.
 - b. Communication survey and collection
 - a. The surveys will be coming out in a day or two. Effective Communication will be the most difficult area to assess due to the need to collect recordings of oral presentations and the unique nature of the collaboration rubric. Dr. Held emphasized that this will stress the system more so than previous years, but that part of assessment is also assessing the process itself. We will learn and adapt.
 - c. LD Core Lock Down and Audit/Review
 - a.Over the summer Dr. Held collected syllabi from courses offered in the LD Core Responsible Living category. The assessment sub-committee will begin its review by looking at these and ensuring that our course offerings exemplify high standards in terms of addressing UCA Core outcomes. Dr. Held reiterates that the process is about high standards and student learning and so this is an opportunity to have conversations with those that offer Core courses to ensure our students are getting the best we have to offer.
 - d. UD Core audit/review
 - a.Dr. Held continues to review the chair questionnaires and have conversations where necessary in terms of offering an accessible and valuable UD Core experience in all major programs.
