## GRADUATE COUNCIL MINUTES Thursday, April 16, 2015, Wingo 315, 1:40 p.m.

## **Action Items:**

- 1. Graduate Council Minutes of March 19, 2015 were approved.
- 2. Bruce Hutchinson, Chair of Subcommittee II, recommended the following changes to the Doctor of Nursing Practice (DNP) degree:
  - a. Approval of the variable credit hour courses for NURS 7415 Clinical Internship (name changed as Information Item below) to NURS 7V15 (1-4 credit hours),
  - b. Approval of the deletion of NURS 7410 Clinical Internship I, and
  - c. Approval of related reduction in total credit hour requirement for the DNP degree from 36 to 34 or higher

Julie Meaux and Barbara Williams from the Nursing Dept. provided additional information and responded to questions from the council.

Vote to approve was unanimous.

- 3. Bruce Hutchinson (Chair, Subcommittee II) recommended the following:

  - c. Approval of a change in degree course requirements in the MSN Clinical Nurse Leader track replacing NURS 6305, 6370 with the addition of NURS 6205 and 6470

Vote to approve was unanimous.

4. Terry James, Chair of Subcommittee III, recommended approval of a change in degree requirements for the PhD in Psychology, adding PSYC 7312 Learning and Cognition as a requirement and reducing dissertation hours from 9 to 6 hours

Vote to approve was unanimous.

- 8. A motion was made by Janet Filer and seconded by Joan Simon to approve the revisions to the M.S.E. in Reading program from the ELSE Dept. (which effectively embeds the Dyslexia endorsement). The revisions include removal of required courses ELSE 6342 and ELSE 6344 plus three credit hours of elective to be replaced with the addition of the following required new courses:
  - a. ELSE 6347 Foundations of Dyslexia and the Language
  - b. ELSE 6348 Multisensory Approach to Language I
  - c. ELSE 6349 Multisensory Approach to Language II

Vote to approve was unanimous.

- 9. A motion was made by Janet Filer and seconded by Rhonda McClellan to approve the new Integrated Birth-Kindergarten endorsement from the ELSE Dept. *Vote to approve was unanimous.*
- 10. Drafts of revised curriculum forms were distributed and discussed. Dr. Bellar asked the council to review the forms and make recommendations for additional changes.
