## Strategic Planning Committee February 2, 2017 Meeting Minutes

The meeting was called to order at 1:40pm by T. Rogers.

## Order of Business:

- T. Rogers stated minutes were not recorded for the December SPC meeting that was jointly held with SBAC however, it will be noted here that Provost Runge and Vice President Newton presented the new performance funding model for the SPARC members at the December meeting.
- 2. T. Rogers led a discussion on whether or not to hold the Strategic Plan spring forums. Points to consider included: (i) wait until next year since we have a spending freeze that has put some of the initiatives on hold; (ii) wait until President Davis has had enough time on the job so he can offer a more supporting role to SPARC; (iii) wait until we have progress to report on the current initiatives; (iv) schedule the spring forums for April and provide the campus with progress-to-date on those initiatives that are happening, like the Pell-eligible scholarships, SI program and Project X and; (v) hold the forums as a way of addressing transparency. It was agreed that T. Rogers would receive direction from President Davis concerning a date to hold the spring forums. She will also compile a list to present at the forums of current and funded initiatives with progress details as well as a summary of those initiatives not being funded due to the spending freeze.
