## IV. Senate Committee Reports

- A. Courtesy Committee
  - 1. The committee sent sympathy, thinking of you, goodbye, get well, and congratulations cards to several individuals on campus.
- B. Football Committee
  - Volunteers will be taking tickets for the second home game of the season on September 30, 2017 (vs Sam Houston State). Staff Senators who are ticket-taking for future home games met earlier this week with Ebony Jackson from Athletics to iron out details with ticket-taking responsibilities.
- C. Compensation Committee
  - 1. The draft is almost done. The summary is due to SBAC in early October. Staff Senate will have the opportunity to see this at the next meeting.

## V. University Committee Reports

- A. Information Technology Advisory Committee
  - 1. A new IST maintenance schedule has been announced. Information can be found at <u>http://uca.edu/ist/maintenance</u>.
  - The Windows 10 rollout process was discussed. The current plan is to have all university workstations migrated to Windows 10 by July 1, 2019. More information on the schedule can be found at <u>http://uca.edu/ist/windows-10-rollout</u>.
  - 3. The University's mobile app was discussed. An update was pushed recently to both iOS and Android app stores. SGA may have some feedback once they get up and running this semester.
  - 4. IST is now supporting both HP and Dell computers. An updated list of supported models, along with purchasing information, can be found at <u>https://uca.edu/ist/technology-purchasing-guide</u>.

- B. Strategic Budget Advisory Committee (SBAC)
  - 1. The committee met on September 26, 2017. Diane Newton delivered a presentation called "Budget 101" to introduce new committee members to the budgeting process at UCA.
  - 2. Funding proposals were discussed. SBAC will hear the funding proposals on October 24, 2017 in the Board room in Wingo Hall; while anyone is welcome to attend these hearings, only committee members are able to ask questions during the hearings, so if any constituents have questions about a specific proposal, they should let an SBAC member know.

  - 4. The committee discussed the difference between the SBAC funding and the zero-based budgeting process. SBAC is only reviewing new initiatives that serve the strategic plan, whereas the zero-based budget is a ground-up approach to building the budget for each division next year.

# VI. Old Business

- A. Steven Shook gave a funding proposal last meeting for becoming a StrengthsQuest Certified Coach in order to provide this training to groups on campus. Secretary Gelwicks collected questions from senators and relayed them to Senator Shook.
  - 1. Question: How do test license costs work with being a certified coach? Answer: It costs \$20 for an individual to take the StrengthsQuest assessment, but higher education individuals gets a \$10 discount. There would be no fee for Steven to do the training if it is delivered on campus.
  - Question: Is there a process for certified coaches to train others on campus in StrengthsQuest facilitation? Answer: Certified coaches can train others to be "instructors" who can assist in co-presenting.
  - 3. Question: How would speaking fees work? Answer: For on-campus groups, there would be no fee. They discuss fees for outside groups at the certification training.
  - 4. Question: How long do test licenses last (i.e. do they expire)? Answer: Codes for taking the assessment do not expire.

- 5. Question: Were you able to contact Dr. Jayme Millsap Stone (who has also training faculty, staff, and students on StrengthsQuest)? Answer: No; she was not on campus when Steven looked for her.
- 6. Question: Are you already a StrengthsQuest instructor? Answer: No.
- Question: What kinds of groups are asking for this training? Is it mostly faculty, staff, or students? Answer: It is diverse, with all three groups asking for this training.
- 8. A concern was raised about the amount of money requested for this certification, as it is large compared to usual funding requests for professional development funding.
  - a) Professional development awards are capped at \$2,000 per applicant per quarter, with the max of \$4,000 per applicant per fiscal year.
- 9. Question: How long has your office existed on campus, and what has been the demand for this training since you started this position? Answer: About 2 years. Steven did about 150 trainings just last year, though not all of them were StrengthsQuest-related.
- 10. Question: What is the cost for someone to become a certified "instructor"? Would it be less if you were training these individuals as a certified coach? Answer: It is about \$600 to become an instructor, though this cost could be less if a certified coach was training them.
- 11. Question: What's the difference between a personality assessment and StrengthsQuest?
  Answer: StrengthsQuest uses more data and is more for long-term personality and strengths assessment, as opposed to other personality assessments (such as Myers-Briggs) which are more for shorter-term, entertainment purposes.
- 12. Question: What would be the main motivation for being a certified coach, versus being a certified instructor? Answer: Coaches are able to train instructors, and it usually takes a certified coach to begin a campus culture of implementing StrengthsQuest throughout departments. Having a certified coach on campus would benefit faculty, staff, and students alike.
- 13. The original motion was made in the last Staff Senate meeting to fully fund the certification costs. The full costs of the conference would be up to

\$7,500, with the possibility of an education discount. This funding would come from Staff Senate's Staff Enhancement Fund.

- 14. Senator Haddick made the motion to approve the funding for \$7,500 to pursue the certification. Senator Eslinger seconded.
  - a) 24 voted "aye" and 3 voted "nay." The motion was approved by the majority. [UPDATE: This motion will be under review in the next meeting per new information.]

#### VII. New Business

- A. The Veterans Day Committee has requested a donation from Staff Senate for the Veterans Day ceremony. Staff Senate has donated to this committee in previous years.
  - This funding would come from the Agency account, which has about \$10,000.
  - 2. Senator Phillips made the motion to donate \$500 to the Veterans Day committee. Senator Ashley-Pauley seconded. Discussion followed about possibly earmarking the funds for a specific purpose in the Veterans Day Celebration. The motion was not changed.
    - a) Question: Is there money left over from previous years? Answer: Yes, but leftover money is often moved over to scholarships. The Veterans Day Committee asks for these donations every year to keep the celebration on budget.
    - b) The motion passed unanimously.

## VIII. Good and Welfare

- A. The Employee Benefits Fair is Friday, October 13, 2017 at 10:00 am-2:30 pm. Staff Senate will have a table at the fair, so senators will have the opportunity to staff the table.
