Guests Jacob Held, Peter Mehl, Jacquie Rainey, and Thomas Snyder were present for information items.

1. Information Items:

- a) Council members and guests watched an online presentation of the *MyMajors* app and reporting tool. P. Poulter asked everyone to visit the *MyMajors* website for additional information and to gather feedback from colleagues at institutions who are using *MyMajors*, particularly the University of Oklahoma since they helped with the development of *MyMajors*.
- b) M. Hargis announced the upcoming Davis Family lecture on October 22nd featuring UCA alum Curtis Barnett. Mr. Barnett, President and CEO of Arkansas Blue Cross Blue Shield, will be speaking on the transferability of skills for leadership.
