Undergraduate Council
November 17, 2020

The Undergraduate Council met via video conference at 1:40 p.m. Members participating included: Carl Frederickson, Debbie Dailey, Shawn Charlton, Suzanne Johnston, Shreya Gopal, Kerry Jordan, David Kim, Ed Powers, Terry Johnson, Jennie Case, Bernard Chen, Susan Perry, Jayme Millsap Stone and Becky Rasnick (NV). Action Items:

1. Dr. Frederickson, on behalf of subcommittee one, made a motion to recommend approval of a proposal from the Department of Biology to change the course level and bulletin description for BIOL 4470 to **BIOL 3470 Biology of Seed Plants**. Dr. Charlton seconded the motion. Motion passed, all in favor.
2. Dr. Frederickson, on behalf of subcommittee one, made a motion to recommend approval of a proposal from the **Department of Computer Science / Data Science / Computer Engineering / Cybersecurity** to **replace required course MATH 2330** in each of the CS majors **with CSCI 2330: Discrete Mathematics for Computing** and update bulletin descriptions for courses CSCI 3330, CSCI 4390 and CSEC 3300 that have MATH 2330 as a prerequisite. Dr. Dailey seconded the motion. Motion passed, all in favor.
3. Dr. Jordan, on behalf of subcommittee two, made a motion to recommend approval of a proposal from the **Department of Mathematics / Data Science** track to change the total credit requirement from 52 to **52-54 hours**; to **remove required course MATH 3391 Non-Parametric Statistics**; and update and **add elective options** for the ancillary course pairs to coincide with the minors (ECON, BIOL, INSU, CSCI, MIS) often chosen by the students. Dr. Powers seconded the motion. Motion passed, all in favor.
4. Dr. Jordan, on behalf of subcommittee two, made a motion to recommend approval of a proposal from the **Department of Family and Consumer Sciences / BS in General Family and Consumer Sciences** to remove CHEM 1402 as a prerequisite for **NUTR 3370 Lifecycle Nutrition I**. Dr. Dailey seconded the motion. Motion passed, all in favor.

5. Dr. Case, on behalf of subcommittee three, made a motion to recommend approval of two proposals from the Department of Music for new courses **MUSA 2V44** and **MUSA 4V44 Guitar**. Dr. Charlton seconded the motion. Motion passed, all in favor.

1. From History: convert **HIST 3312** to online delivery.
2. From Marketing and Management: convert **MGMT 2341** to online delivery.
3. From the College of Business: delete degree and certificate programs for CP, TC, AAS, Law Enforcement Administration and CP, TC, AAS, Crime Scene Investigation.
4. From Exercise and Sport Science: delete the BS degree program in Athletic Training.
5. From Psychology and Counseling: remove the prerequisite “six hours of psychology” and add PSYC 1300 to course **PSYC 3350**.

7. From EFIRM: remove the Effective Communication Goal A-Oral from **ECON 3302** Intermediate Macroeconomics.
8. From EFIRM: remove the Effective Communication Goal C-Collaboration from **FINA 4336** Advanced Financial Management.
9. From EFIRM: remove the Effective Communication Goal C-Collaboration from **INSU 4320** Corporate Risk Management.
10. From Marketing and Management: remove the Effective Communication Goal A-Oral from **MKTG 4355** Marketing Management.
11. From Marketing and Management: remove the Effective Communication Goal A-Oral from **MGMT 4376** New Venture Creation.
12. From Music: change course title for **MUSE 2210/4110** from Concert / Chamber Choir to just Concert Choir.
13. From Music: add **MUSA 2V44/4V44** Guitar as an option to fulfill applied music credit hour requirements.
