

**MINUTES**  
**Undergraduate Council**  
**December 1, 2022**

The Undergraduate Council met in Wingo Hall 315 and via video conference.

The meeting was called to order at 1:40 p.m.

Action Items:

1. Dr. Charlton, on behalf of subcommittee one, made a motion to recommend approval of two proposals from the Department of Computer Science and Engineering / Cybersecurity: (a) to add a BS + MS combined (4 + 1) option; and (b) to remove PHIL 4320 (Applied Ethics) as a required core option in the BS program. Dr. Alex Chen seconded the motion. Motion passed, all in favor.

Dr. Charlton, on behalf of subcommittee one, made a motion to recommend approval of a proposal from the Department of Computer Information Systems and Analytics to change the course name and description for CISA 4320 from Critical Thinking and Experimental Design to Critical Thinking in Data Analytics.
