<sup>1</sup> See appropriate choices, alternatives, or substitutions under "UCA Core" in the *Undergraduate Bulletin*. During the first year, a student must complete a UCA Core course designated as a First-Year Seminar (FYS) in Critical Inquiry, Diversity, or Responsible Living. Note: Students may be able to take a UCA Core course required for the major as a FYS option. The student would then substitute another UCA Core course in its place on the PCP. For example, if a student took ECON 2310 as a FYS, they would need to replace ECON 2310 on the PCP with a different UCA Core course. The student will also need to complete major, minor, or general elective courses designated as fulfilling the upper-division and capstone requirements of the UCA Core.

<sup>2</sup> All BBA students must take ECON 2310, MGMT 2301, ECON 2320, and ECON 2321 as part of their Business Foundation courses. Nine of these hours (ECON 2310, MGMT 2301, and either ECON 2320 or ECON 2321) will count towards both BBA degree requirements and the UCA Core requirements.

<sup>3</sup> If approved by the student's academic advisor, a student may take QMTH 2330 in semester 2 and MATH 1395 in semester 3 or semester 4.

<sup>4</sup> Students may take their UCA Core Science classes in any space designated UCA Core course. However, at least one Natural Science course must be completed in the first year.

<sup>5</sup> In order for a BBA-seeking student to enroll in more than nine (9) hours of upper division courses in the College of Business, they must meet the following progression requirements:

1. Obtain a 2.0 or higher cumulative grade point average, and
2. Complete ACCT 2310, 2311, ECON 2320, 2321, QMTH 2330 with a 2.0 grade point average in these five courses.

<sup>6</sup> FINA 3330, MGMT 3340, MGMT 3344, MKTG 3350, MIS 3321. These courses have a prerequisite requirement of the following courses ACCT 2310, ACCT 2311, ECON 2320, ECON 2321, QMTH 2330.
