## University of Central Arkansas Eight-Semester Degree Completion Agreement

Pursuant to Act 1014 of 2005, qualified first-time freshmen—those who have selected a major and whose major has a published eight-semester plan included in this agreement—may elect to participate in the Eight-Semester Degree Completion Agreement ("Agreement"). Majors included in the Agreement are listed in UCA's <a href="Academic Maps website">Academic Maps website</a> and linked from the <a href="Undergraduate Bulletin">Undergraduate Bulletin</a>. A qualified student must accept or waive participation in the Agreement.

By choosing to participate in this Agreement, students accept responsibility for monitoring their progress toward their chosen degrees, for regular consultation with their official academic advisors, and for making choices that will lead to graduation in eight semesters.
