The bid of George W. Donaghey (\$87,740.00) being the lowest on the general contract, he was declared the lowest and best bidder and was by motion awarded the contract for the building, said building to be completed within eight months unless prevented by absolutely un-avoidable accidents or conditions.

The bid of Casey Naylor of Little Rock being the sum of \$1,800.00 he was declared the losest bidder and awarded the contract for the electrical work in the said Administration building.

All plumbing and heating bids were by motion rejected by reason of the uncertain condition of the markets at this time. The Secretary was authorized to re-advertise for the bids for plumbing and heating to be submitted to this Board at a special meeting to be held October 10th, 1917, at two o'clock P. M. The advertisement is to call for separate bids on each.

The architect was ordered to draw up contract between the Board of Trustees and the suucessful bidders for the erection of the building and electric work to go therein.

President Torreyson was authorized to purchase for the school a blackboard, 3 digits kindergarten chairs and three teachers desks, all of which was asked for by the president.

Without objection it was ordered that one hald of the architect's fee be paid upon signing of all contracts, same amounting to \$2,238.50. A.

Q. L. Hutchins was allowed the sum of \$18.80, expenses attending Board meetings September 21st and September 26th.

The Board adjourned.
