**A. Resolution of Appreciation – Joe Whisenhunt**

**RESOLUTION OF APPRECIATION**

WHEREAS, Joe Whisenhunt of Conway, Arkansas, was appointed to the Board of Trustees of the University of Central Arkansas by the Governor of the State of Arkansas, Asa Hutchinson, in February 2015 for a term of seven years; and

WHEREAS, Mr. Whisenhunt served as chair of the Board of Trustees in 2018 and attended many university events and function in his capacity as chair; and

WHEREAS, during his term as chair of the Board, the University made significant progress by (a) advancing the Steinway Initiative, (b) completing the renovation of Hughes Hall, (c) beginning construction on the Dave Ward Drive pedestrian bridge overpass, (d) beginning the renovation of Conway Hall, (e) approving the construction of the Integrated Health Sciences Building, (f) approving the renovation of State and Carmichael Halls, and (g) beginning an information technology refresh; and

**VII. ACTION AGENDA**

**B. Reimbursement of Expenses for Official Board of Trustees Duties – Board Policy No. 211**

Arkansas Code Annotated 25-16-901 et seq. provides that boards and commissions may, during their first regularly scheduled meeting of each calendar year, authorize expense reimbursement for each board member for performing official board duties. The law states that the expense reimbursement must not exceed the rate established by state travel regulations for state employees. The law covers expense reimbursement for all board functions. This action is consistent with Board Policy No. 211, Reimbursement of Expenses for Official Board of Trustees Duties, and Arkansas Code Annotated 6-67-102.

Therefore, the president recommends to the Board of Trustees the following resolution:

**BE IT RESOLVED: That the Board of Trustees approves the following statement concerning reimbursement of expenses for official board duties for 2019:**

**The UCA Board of Trustees authorizes reimbursement of expenses for each of its members for performance of official board duties, to include attendance at board meetings, fulfillment of board training requirements, and any other official board duties. The expense reimbursement authorized herein must not exceed the rate established by state travel regulations for state employees, including special travel authorization. The board also authorizes the president to approve the reimbursement of travel expenses of board members that are in conformance with this policy.”**

The University of Central Arkansas Board of Trustees authorizes reimbursement of expenses for each trustee for performance of official board duties, to include attendance at board meetings, fulfillment of board training requirements, and any other official board duties. The expense reimbursement authorized herein must not exceed the rate established by state travel regulations, including special travel authorization. The board also authorizes the president to approve the reimbursement of travel expenses of board members that are in conformance with this policy.

### C. Contract Review Procedures – Board Policy No. 416

Pursuant to Board Policy No. 416, Contract Review Procedures, the administration must seek board approval for any contract that requires the university to expend funds, at any time, in excess of \$250,000 or any contract with a term exceeding one year, unless the Office of General Counsel certifies, in writing, that the contract (a) may be terminated by the university on the giving of written notice of 90 days or less or (b) will not require the university to expend funds in excess of \$99,999.

The administration is seeking board approval for the university to enter into contracts with the following companies/organizations:

- Alternative Communications
- Estage Property Management
- Aramark Educational Services, LLC
- Benefitfocus.com, Inc.

Therefore, the president recommends to the Board of Trustees the following resolution:

**“BE IT RESOLVED: That the Board of Trustees authorizes the administration to enter into the contracts with the companies/organizations listed above and on the following page.”**

**Vendor/Party:** Alternative Communications

**Amount:** \$380,000 (this amendment is for \$300,000)

**Summary of Contract Information:** This is an amendment to an existing contract to increase the available funding. The purpose of the contract is to provide reading transcription services for students registered with the university Disability Resource Center.

**Term:** Contract expires January 31, 2022

**Vendor/Party:** Estage Property Management, LLC, (The Edge Apartments)

**Amount:** \$278,400

**Summary of Contract Information:** The purpose is to rent 48 beds (12 units) from The Edge for upper class student housing during the 2019-20 academic year.

**Term:** August 17, 2019 to May 2, 2020.

**Vendor/Party:** Aramark Educational Services, LLC

**Amount:** The proposed agreed upon average rate increase for meal plans is 5.02%

**Summary of Contract Information:** The purpose is to provide food services for the campus. Under the terms of the contract, Aramark and UCA mutually agree upon an appropriate increase to the meal plan rates, utilizing the most recent 12-month increases in the October Consumer Price Index for All Urban Consumers (CPI-U). The October 2018 CPI-U was 2.5%. Factors that contributed to the rate increase this year include the increase in minimum wage, the addition of two cafeteria supervisors with emphasis on nights and weekends, and an increase in residential dining by adding two evening hours.

**Term:** The Board of Trustees approved the original contract in April 2012. The contract was effective June 1, 2012, and is renewable for up to 10 years. The Board most recently approved a revision in May 2018.

**Vendor/Party:** Benefitfocus.com, Inc.

**Amount:** \$252,732 (estimate based on employee use)

**Summary of Contract Information:** The purpose is to provide online services to the university for administration of benefits, including enrollment, health savings accounts, and flexible spending accounts.

**Term:** Three years.

### **D. Property Acquisition – 1902 and 1910 South Boulevard, Conway, AR**

Deep Well Campus Ministries, Inc. (Chi Alpha) owns the houses located at 1902 and 1910 South Boulevard, Conway (hereinafter collectively referred to as property). Deep Well contacted the university about selling the property. The property is located at the intersection of South Boulevard and Mitchell Street, an area UCA has been acquiring property for future development. The university recently purchased the property across the street at 1903 South Boulevard. The university also owns the adjacent property located at the corner of South Boulevard and Baridon Street.

UCA is in the process of purchasing the buildings on Bruce Street that house the Catholic Campus Ministry and the Baptist Collegiate Ministry. Those properties must be acquired for construction of the Integrated Health Sciences Building. The tentative plan is for those two organizations to relocate to property on South Boulevard currently owned by UCA. The acquisition of 1902 and 1910 South Boulevard will replace part of the land lost in the relocation and will potentially provide two buildings for temporary use by staff or organizations.

The university has signed an offer and acceptance with the seller for \$240,343. A copy of the signed agreement is attached. The terms of the agreement include a 95-year lease for land on College Avenue for one dollar per year. The land on College Avenue is adjacent to the land similarly leased to the Perspective College Ministry.

The house at 1902 South Boulevard was built in 1952 and is approximately 1,204 square feet. Deep Well purchased the property in 2015 for \$115,000, which is the value being used for the university purchase. The house at 1910 South Boulevard was built in 1952 and is approximately 1,184 square feet. Deep Well purchased the property in 2016 for \$125,343, which is the value being used for the university purchase.

The closing of the proposed acquisition is conditioned upon the approval of the Board of Trustees.

Therefore, the president recommends to the Board of Trustees the following resolution:

**“BE IT RESOLVED: That the Board of Trustees approves the transaction described above with the Deep Well Campus Ministries, Inc., for the sale and purchase of two houses with street addresses of 1902 and 1910 South Boulevard, Conway, Arkansas, for the sum of \$240,343 and a 95-year lease for land on College Avenue, and the president and such other officials of the University of Central Arkansas, as the president may from time-to-time designate, are hereby authorized and directed to enter into and execute such other documents, agreements, and instruments as are necessary and required to consummate the foregoing purchase.”**

Dear Deep Well Campus Ministries:

Subject to the satisfaction of all of the provisions and conditions set forth herein, the Board of Trustees of the University of Central Arkansas (“**Buyer**”) offers to purchase from the Deep Well Campus Ministries, Inc. (“**Sellers**”) the property described below for the sum of Two Hundred Forty Thousand Three Hundred Forty-Three Dollars (\$240,343), plus the Buyer’s share of the closing costs.

The property subject to this offer and acceptance is two houses and lots located at 1902 and 1910 South Boulevard, Conway, Arkansas, 72034, and is more particularly described as follows:

**Lots 22, 23, and 24, Block 70, Boulevard Addition to the City of Conway, Faulkner County, Arkansas. Also, 10 feet of a closed 20 foot alley on the western border of Lot 22 and 10 feet of a closed 20 foot alley on the northern borders of Lots 22, 23, and 24, being closed by Ordinance No. O-07-69.**

The foregoing legal description shall be referred to as the “Property.” If a survey shall establish a different legal description, the parties agree to modify the legal description to conform to the survey, the intent of the parties being that the entire parcel owned by the Sellers is to be conveyed at closing.

The terms and conditions of this offer to purchase are as follows:

1. The closing date will occur at a mutually acceptable date to be agreed upon by both parties, but shall occur not later than **March 29, 2019**;
2. Buyer shall be entitled to possession of the Property at closing;
3. A policy of title insurance satisfactory to Buyer, insuring unencumbered fee simple title to the Property in Buyer as of closing shall be procured and paid for by Sellers;

4. Sellers shall deliver at closing (a) a warranty deed in standard form conveying fee simple absolute title to the Property (and any mineral interests owned by Seller), free from all liens, claims or encumbrances of any kind with the grantee being "The Board of Trustees of the University of Central Arkansas" and (b) an assignment of any leases and all rents from the Property, if any;
  5. Any and all taxes or assessments on the Property for the current year will be prorated at closing. Sellers shall be responsible for all real property taxes for previous years;
  6. Buyer and Sellers will share the cost of closing fees and document preparation. No revenue stamps shall be required due to an exemption under Arkansas law for conveyances by or to a state agency (Buyer);
  7. If any personal property shall be stored or situated on the Property, the same shall be removed prior to closing;
  8. Sellers represent and warrant to Buyer that Sellers are the sole owner of the Property, and no other person or entity has any form of ownership interest in, or right to use or occupy the Property, and further, that Sellers are in sole and exclusive possession of the Property, except for leases, copies of which have been delivered to representatives of Buyer;
  9. Sellers represent and warrant to Buyer that all liens against the Property and all money owed on the Property, if any, are the responsibility of Sellers, and if existing will be satisfied and paid in full at, or prior to, closing;
  10. Sellers represent and warrant to Buyer that there are no unrecorded rights-of-way for roadway, utilities or other matters affecting the Property;
  11. Sellers represent and warrant to Buyer that there is no loss arising from oil, gas, or other minerals conveyed, retained, or assigned, or from any other activity concerning sub-surface rights or ownership of the subject property, including but not limited to the right of egress or ingress for said sub-surface purposes;
  12. Sellers represent and warrant to Buyer that there are no proceedings, either pending or threatened, which, if decided adversely to Sellers, would constitute a lien on the Property; nor are there any money judgments entered by a court against Sellers that constitute a lien on the Property.
  13. Sellers represent and warrant to Buyer that there are no unrecorded contracts of sale, options to purchase, or any other kind of agreement with any person or entity, affecting the Property;


14. Sellers shall be responsible for all risk of loss to the Property and improvements thereon (if any) prior to closing;
15. If Buyer desires to have a survey of the Property performed prior to closing, Sellers agree to cooperate in having the survey performed. Any survey shall be at the expense of Buyer;
16. Sellers represent and warrant that to the best of Sellers' knowledge, no hazardous wastes or materials of any kind have been generated, produced or stored upon the Property, and that to the best of Sellers' knowledge, no such hazardous wastes exist today on the Property; and
17. Sellers shall complete and deliver, prior to closing, the attached "Disclosure Form" which will become part of the Offer and Acceptance document. Failure to make any disclosure required by the Governor's Executive Order 98-04, or any violation of any rule, regulation, or policy adopted pursuant to that order, shall be a material breach of the terms of the contract. Any contractors, whether an individual or entity, who fails to make the required disclosure or who violates any rule, regulation, or policy shall be subject to all legal remedies available to the Buyer.
18. Buyer's obligations under this agreement are expressly conditioned upon the prior approval of the Board of Trustees of the University of Central Arkansas. This agreement and Buyer's obligations hereunder shall not be a valid and binding legal obligation of Buyer until approved by resolution duly adopted by the Board of Trustees of the University of Central Arkansas.
19. Buyer will lease and let unto Sellers unimproved real property located on College Avenue. The property is identified as Tract 1 on the attached Exhibit A. Sellers shall be granted a 95-year lease at the rate of \$1 per year, subject to signing of a lease agreement prepared by Arkansas Building Authority. The property must be used for construction of a building by the Sellers, subject to University approval, that will be used for ministering to University students in a similar manner to your current operations. Sellers shall not lease, sublease, sell, or permit the use of any portion of the property. In the event you vacate the premises, or the lease expires, the University would have the option to purchase the improvements for their then fair market value as determined by appraisals.

If the terms are agreeable to you, please sign and deliver the original to Warren Readnour, General Counsel, University of Central Arkansas, Wingo Hall 207, 201 Donaghey Avenue, Conway, AR 72035. If you have any questions, you may call Mr. Readnour at 501-450-5007.

### E. Central Pool Positions

The State of Arkansas (Arkansas Code Annotated § 21-5-415) provides that the Department of Higher Education shall maintain a central pool of positions to be used for additional positions when a university does not have sufficient positions available. The university must provide justification to the Department of Higher Education for the need to allocate a position from the central pool. The administration is seeking the addition of two non-classified positions in the information technology department to reclassify two existing employees. The positions are Director of Information Security and Director of Networking. As part of the university's strategic plan, UCA is undertaking a network infrastructure upgrade project and has increased its operations with regard to the protection of information.

Therefore, the president recommends to the Board of Trustees the following resolution:

**"BE IT RESOLVED: That the Board of Trustees authorizes the administration to proceed with a request for two additional non-classified positions from the central pool maintained by the Department of Higher Education."**

## VI. ACTION AGENDA

### F. Certification of Sufficient Appropriations and Fund Balances

In accordance with State Accounting and Budgetary Procedures law, the Board of Trustees is required to annually certify that the university will not incur any obligations without having sufficient appropriations and funds available during the fiscal year for the payment of the obligations when they become due.

Therefore, the president recommends to the Board of Trustees that this certification be approved and submitted to the chief financial officer of the State of Arkansas as required by Arkansas law.

**“BE IT RESOLVED: That the Board of Trustees approves the following certification and will continue to monitor the obligations of the university to insure that sufficient appropriations and fund balances are available to pay all future obligations of the institution when such obligations become due.”**

**G. Bond Feasibility Study and Reimbursement Resolution**

Request to Proceed with a Feasibility Study for the issuance of bonds, in an amount not to exceed \$20,000,000. The bond proceeds will support the planning, design, and construction of The Windgate Center for Fine and Performing Arts at an estimated cost of \$45,000,000. The bonds will have a maximum term of thirty (30) years at an estimated annual interest rate not to exceed 5.00 percent. The Windgate gift of \$20,000,000 was announced on January 22, 2019, \$19,000,000 of which is designated for this project. The balance of the funding will be secured through additional fund raising.

The Windgate Center is being designed as an estimated 114,000 square feet facility. Forty percent of the facility is dedicated art space, which will include an exterior location for three-dimensional art and gallery space. The Windgate Center will also include a 450-seat concert hall and a proscenium theatre. The university engaged WER Architects in 2018 to provide preliminary architectural services for a new Fine and Performing Arts building. The WER contract must be amended and the spending limits increased in order to proceed with planning of the project.

The Educational and General (E&G) issue will be up to \$20,000,000 with an estimated maximum annual debt service of \$1,300,000 and a term of thirty (30) years. The debt service for the bond issue will be supported by tuition and fee revenue as well as college based fees sufficient to support the additional debt service. Arkansas Higher Education Coordinating Board (AHECB) policy regarding debt service for education and general projects provides that a maximum of 25 percent of net student tuition and fee revenue may be pledged to E&G debt service.

**Educational & General Issue (E&G)**

Actual 2017-2018 Tuition and Fee Revenue .....	\$ 62,889,305
Maximum Allowable Debt Service (\$62,889,305 X 25%).....	\$ 15,722,326
Existing Debt Service .....	\$ 6,168,407
Proposed New Debt Service .....	\$ 1,300,000
Amount Remaining for Additional Debt Service .....	\$ 8,253,919

The above data demonstrates that the university has sufficient tuition and fee revenue to support an E&G bond issue of up to \$20,000,000 with a term of thirty (30) years at an estimated annual interest rate not to exceed 5.00 percent.

In accordance with the AHECB’s policy, UCA will sustain a building maintenance fund to be supported by tuition and fee revenue for the E&G facilities. These funds will be held in a separate account for the maintenance of the new facility by transferring annually to plant funds based on the Association of Physical Plant Administrators (APPA) of Universities and Colleges recommendation. The current APPA recommendation is \$2.50 per gross square foot for E&G facilities.

The project will add an estimated 114,000 square feet. Therefore, based on the estimated new square feet for the project, \$285,000 will be transferred annually beginning in the fiscal year after the project is placed into service.

**The administration is requesting that the Board of Trustees grant authority to proceed with a feasibility study for a bond issue to fund the design and construction of The Windgate Center for Fine and Performing Arts.**

**The administration is also requesting approval of a resolution that, in part, authorizes the university to use certain bond proceeds to reimburse expenses incurred prior to the issuance of bonds, designates Friday, Eldredge & Clark, LLP as bond counsel, and designates Crews & Associates, Inc. as underwriter for the bonds.**

If the request to issue bonds is approved by the AHECB, another resolution on this topic will be presented to the Board of Trustees at a future meeting.

Therefore, the president recommends to the Board of Trustees the following resolution:

**“BE IT RESOLVED: That the Board of Trustees hereby approves the two attached resolutions and authorizes the administration to proceed with the planning of the project to include actions necessary in amending the WER Architects contract, and in securing engineers and contractors, and authorizes the president of the university, or his designee, to take such other steps and execute such other documents as may be necessary or required to carry out the project and the intent of this resolution.”**

**WHEREAS**, The Board of Trustees authorizes and recommends the commencement of

preparations for securing a bond issue in an aggregate principal amount not to exceed \$20,000,000 for the purposes described above.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES THAT:**

**Section 1.** The Board of Trustees of the University of Central Arkansas hereby authorizes the administration to commence all necessary preparations to issue bonds in an amount not to exceed \$20,000,000 with a term not exceeding 30 years and at an interest rate not to exceed 5.00%, with terms and conditions satisfactory to the administration, subject to final review and approval by resolution of this Board.

**Section 2.** The Board further authorizes the administration to seek approval from the Arkansas Higher Education Coordinating Board for issuing the bonds.

**Section 3.** The bonds will be secured for the purpose of design and construction of The Windgate Center for Fine and Performing Arts.

TO ASSIST THE BOARD IN THE ISSUANCE OF THE BONDS; AND  
SETTING FORTH OTHER MATTERS PERTAINING THERETO.

WHEREAS, the Board of Trustees (the "Board") of the University of Central Arkansas (the "University") is authorized under the Constitution and laws of the State of Arkansas, including particularly Act No. 62 of 1947 (codified at Sections 6-62-301 et seq. of the Arkansas Code Annotated) (the "Act") to borrow money for the acquisition, construction, renovation, improvement, equipping, and furnishing of buildings, structures, and other capital improvements which the Board deems proper or suitable for the purposes of the University; and

WHEREAS, the Board has determined and hereby finds and declares that there is a need for certain capital improvements on or for the campus of the University, including the following: (i) the acquisition, construction, equipping and furnishing of the Windgate Center for Fine and Performing Arts; and (ii) the acquisition, construction, improvement, renovation, equipping and/or furnishing of other capital improvements and infrastructure and the acquisition of various equipment and/or real property for the University (collectively, the "Project"); and

WHEREAS, it is anticipated that a portion of the costs of the Project will be financed with proceeds of revenue bonds in an aggregate principal amount not to exceed \$20,000,000 to be subsequently approved by the Board (the "Bonds") and secured by a portion of the general tuition and fees paid by students attending the University; and

WHEREAS, the Board intends that prior to the issuance of Bonds certain costs relating to the Project will be incurred and paid from certain funds and accounts established and administered by the University; and

WHEREAS, the Board wishes to express its current intent to reimburse certain funds and accounts for all expenditures related to the Project from the proceeds of the Bonds and desires that, with respect to the Bonds, such reimbursement comply with Treasury Regulation Section 1.150-2 (the "Regulation") so that proceeds of the Bonds will be deemed spent when such reimbursement is made; and

WHEREAS, the Board intends to issue the Bonds pursuant to a definitive resolution or resolutions to be subsequently adopted for such purpose or purposes;

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the University of Central Arkansas:

Section 1. The Board currently contemplates that the Project will include the capital improvements described above.

Section 2. The Board intends to issue the Bonds, in an aggregate principal amount not to exceed \$20,000,000, for the purposes of financing a portion of the costs of the Project, funding capitalized interest (if necessary or desirable), and paying costs of issuing the Bonds. The Bonds will not be issued until the final terms or parameters of the proposed issuance have been presented to and approved by the Board.

Section 3. Costs incurred in accomplishing the Project prior to the issuance of the Bonds will be paid from certain funds and accounts established and administered by the University. The Board intends to use certain proceeds from the issuance of the Bonds to reimburse such accounts. This Resolution shall constitute an "official intent" for purposes of the Regulation.

Section 4. The President of the University and other appropriate officials are hereby authorized to present such information as they deem appropriate to the Arkansas Higher Education Coordinating Board for its advice with respect to the economic feasibility of the Projects.

Section 5. The Board hereby designates Friday, Eldredge & Clark, LLP, Little Rock, Arkansas as bond counsel for the Bonds and Crews & Associates, Inc. as underwriter for the Bonds.

Section 6. The provisions of this Resolution are hereby declared to be separable and if any provision shall for any reason be held illegal or invalid, such holding shall not affect the validity of the remainder of this Resolution.

Section 7. All resolutions and parts thereof in conflict herewith are hereby repealed to the extent of such conflict.

## VIII. NOTIFICATIONS AND DELETIONS

### A. Deletion of the Physical Therapy Track in the BS in Health Sciences

The Department of Physical Therapy proposes to delete the Physical Therapy track from the BS in Health Sciences degree. The primary rationale for the deletion is that it currently exists solely to prepare students for entry into the university's Doctor of Physical Therapy (DPT) program, yet the majority of the students who earn the degree cannot be admitted to the DPT program. The Physical Therapy track within the BS in Health Sciences degree originated in 1989 as a precursor to UCA's then Master of Science (MS) degree in Physical Therapy, and it worked well for that program. The MS in Physical Therapy was a 3+2 degree, and only students admitted to the master's degree program in Physical Therapy were awarded the degree (upon completion of the first year of the MS program).

With the termination of the MS degree and the advent of the DPT degree in 2000, students were required to have completed a bachelor's degree prior to admission into the DPT program. The BS in Health Sciences–Physical Therapy track was modified to serve as a baccalaureate degree that would serve students pursuing admission into physical therapy in that the degree incorporated prerequisites required for the DPT program. However, because of consistently rising applicant numbers (currently approximately 400 applications for 60 positions), less than 35% of students earning the BS in Health Sciences with the emphasis in Physical Therapy are admitted into the DPT program at UCA. The Physical Therapy faculty believe that our aspiring students will be better served by earning a degree that is widely recognized and could lead to employment in another field or to graduate education in the field should they be unsuccessful in admission to a DPT program.

Currently 310 students are enrolled in the Physical Therapy emphasis, and it is expected that all will be graduated by August 2024.

To serve the needs of incoming undergraduate students interested in Physical Therapy, the department has identified at least six other undergraduate majors that contain the prerequisites for UCA's DPT program. Upon initial advisement and throughout the freshman year, this list will be provided to students by the pre-DPT program advisor. Students uninterested in one of the six majors incorporating DPT prerequisites will be counseled by the pre-DPT program advisor to pick a major of interest to them, and a plan will be made with the student for incorporating the DPT prerequisites into the plan of study.







The Department of Accounting has proposed a new undergraduate Technical Certificate (TC) in Accounting. The certificate program uses courses that are already part of the undergraduate program in Accounting and responds to student need. Approximately 20 students each year contact Department of Accounting about returning to school to study accounting. UCA currently offers three options for these students: (1) take accounting courses but earn no new credential, (2) complete a second bachelor's degree, or (3) complete undergraduate prerequisites and then complete a Master of Accountancy. Options 1 and 3 are the most popular, option 1 because it requires the fewest hours and option 3 because it is often close in hours to option 2 and students would prefer to leave with a graduate degree instead of a second undergraduate degree. With the proposed TC in Accounting available to them, students selecting options 1 and 3 would be eligible to earn a credential for their undergraduate work.



### F. Curricular Changes to Graduate Programs in Special Education

To meet the Science of Reading Competencies requirement from the Arkansas Department of Education (ADE), the Department of Elementary, Literacy, and Special Education are implementing minor changes to three graduate programs in Special Education:

(1) The Graduate Certificate (GC) in Special Education K-12 removes one course, adds one course, and adds a second course for students who have not previously established competency in the Science of Reading. Required hours, therefore, change from 21 to 21-24 semester credit hours, depending on the prior preparation of the student.

(2) The Master of Arts in Teaching (MAT) in Special Education K-12 removes one course and adds two courses. Required hours, therefore, increase from 36 to 39 semester credit hours.

(3) The Master of Science in Education (MSE) in Special Education K-12 removes two courses and adds two courses. Required hours, therefore, remain 30 semester credit hours.


