VI. ACTION AGENDA

A. Acceptance of Legislative Audit Report for Fiscal Year 2019

In accordance with Act 4 of 1991, the Board of Trustees is required to review audit reports and the accompanying comments related to publicly-funded institutions. The act requires that the board take appropriate action related to each finding and recommendation contained in the report.

There were no audit report findings for fiscal year 2019. The audit was provided to management and was submitted for the board's review prior to the October 9, 2020 meeting.

Therefore, the president recommends to the Board of Trustees the following resolution:

B. Contract Review Procedures – Board Policy No. 416

Pursuant to Board Policy No. 416, Contract Review Procedures, the administration must seek board approval for any contract that requires the university to expend funds, at any time, in excess of \$250,000 or any contract with a term exceeding one year, unless the Office of General Counsel certifies, in writing, that the contract (a) may be terminated by the university on the giving of written notice of 90 days or less or (b) will not require the university to expend funds in excess of \$99,999.

The administration is seeking board approval for the university to enter into contract with the following company/organization:

1. Fraley Roofing Inc.

Therefore, the president recommends to the Board of Trustees the following resolution:

“BE IT RESOLVED: That the Board of Trustees authorizes the administration to enter into the contract with the company/organization listed above and on the following page.”

C. Insurance Services

Health and Dental Insurance

The Employee Benefits Advisory Committee (EBAC) and Stephens, Inc., UCA's health plan consultant, have met with UCA administration and recommend no premium increase for the 2021 Health and Dental insurance rates. The only recommended change is to increase the dental plan annual benefit maximum from \$1,000 to \$1,250.

The UCA health plan is in its fifth year of self-insurance and, as of September 30, 2020, the plan has a surplus of \$1,232,734 above what it is required to have set aside to pay claims.

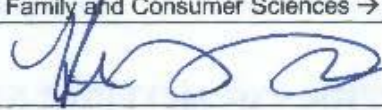

7. Reason for proposed action

After much deliberation, voting, and serious consideration, faculty in the Department of Family and Consumer Sciences are requesting a name change for the Department. We researched programs similar in nature to our own at our peer and aspirant institutions as well as reviewed programs accredited for education in Family and Consumer Sciences as well as the Accreditation Council for Education in Nutrition and Dietetics. After completing this exercise, we have concluded that a change is needed in order to remain visible and relevant in the competitive marketplace of higher education.

Faculty present at the Spring Strategic Planning Retreat voted unanimously in favor of and therefore propose changing our name to the Department of Nutrition and Family Sciences. This title will more accurately reflect our curriculum, mission, and vision. As we work to enhance our Department with research and teaching expertise, we feel the name will give us better recognition and a more marketable presence.
