- 2. Dee Dee Cain provided special education updates and led discussion around:
  - Recruitment and Residences. The committee noted the number in the undergraduate programs were low and recruitment ideas were discussed. The implementation of a residency program is ongoing and is planned for future semesters.
  - HQIM materials: Materials have been purchased and are housed in TLC. Professional development for COE will be provided on the use of the HQIM in schools and its impact on teacher preparation. It was suggested the early exposure to HQIM for teacher candidates in preadmit courses (ELSE) 3390.
  - K-12 report will be sent out at a later date.
  - Numbers are good in the special education minor program

- 3. Dr. Keith Lenz provided special education updates and led discussion around:
  - MSE program report indicated that numbers were good at approximately 60 candidates.
  - Suggestions concerning addition of a course in the MSE program.
  - Discussion around some revisions to the MAT coursework including suggestions for changes to model assessments-Dr. Lenz will look at the recent data to determine if these changes are needed.
