#### B. Other Announcements and Concerns

Senator Burley: AAUP Spring Fling at Mike's Place 4 PM 3/7/2013.

Senator Bradley: Impressed with Athletic Comm report and academic integrity metrics. Asks that University endorse NCAA minimum requirements for admission.

Senator J. Wilson: Several UCA faculty and I would like the faculty senate to discuss the item at the end of this email and ask the administrator to stop supporting the event. This announcement was sent to all faculty by email on 2-19-2013 with the subject line: Leadercast Conference for UCA Employees. (1) We are concerned that UCA is co-hosting/sponsoring a conference to be held at a religious site. UCA is not a religious institution and should not be holding any events at any religious site. Although the religious site may offer a venue to accommodate the anticipated numbers of people, if the event is co-hosted/sponsored by UCA, then it should be held on the UCA campus. Not all religious sites welcome all people. (2) UCA is co-hosting/sponsoring an event that is connected to chick-fil-a, a company that does not honor equity among all people. This company aggressively contributes to anti-gay and lesbian organizations. (3) The email announcement was distributed by Charlotte Strickland, Office of University Training, who organizes and delivers diversity training. Information relating to an event held at a church and connected to an anti-gay and lesbian organization should not be distributed by the university personnel responsible for diversity training. Events held at churches and connected to openly hate groups should not be any part of UCA personnel or procedures. (4) UCA students want the SGA as well as administrators, faculty, and staff to support and improve relations with university programs for LGBT students. The Leadercast Conference does not support or improve relations for LGBT students; the Leadercast Conference appears to focus on just the opposite, which may be intentional. (5) An article about minority groups printed in The Echo dated 2-13-2013, described counselors that are hostile toward LGBT students seeking guidance...often working with a "Christian mindset." Christianity does not dictate unacceptance of LBGT individuals. Many Christians advocate human rights and equality for all people. However, the Leadercast Conference, co-hosted/sponsored by UCA is being held in a church that may not advocate human rights and equality for all people especially as it is connected with a corporation that aggressively contributes to anti-gay and lesbian or organizations, therefore communicating the

inaccurate belief that Christians are not supportive of all people. We urge the UCA faculty senate to request UCA and the Office of University Training to stop co-hosting/sponsoring this event and to stop distributing information about the event through the UCA email. Thank you.

Senator Crocket:

It increasingly appears as if the legislature is going to pass a bill allowing faculty/staff to carry firearms on campus. Governor Beebe has indicated that he would sign such a bill:
