- **President's Comments:** President Davis
 - Provided preliminary updates from ADHE on fall full-time freshman cohorts in AR, UCA is doing extremely well compared to other Arkansas institutions.
- **Provost's Comments:** Provost Hargis
 - Provided updates on UCA's Strategic Planning Process
 - Phase 1-this phase has been about reflecting on where we are today, our past strategic planning efforts, and what worked and what didn't work. The Steering Committee has almost finished this process.
 - Phase 2 during the spring 2025 semester we will be encouraging participation and holding small group/unit discussions
 - Phase 3 during the summer months we will begin to build out the pillars for our new strategic plan
 - Phase 4 during the fall semester we will begin to finalize the plan, which should be done by early December.

• FS President's Comments: FS President Shires

- Salary Study is moving along. A lot of work was done to respond to Gallagher's initial benchmarks and get more accurate pictures of our positions. UCA can expect to see the next data file and update post-Thanksgiving. This is called the 'employee pay file' and should provide detailed salary ranges and market information for all positions. Though we will not have adequate time to review and meet with VPs and their direct reports (Deans, as an example) before winter break, we want to give them time to start reviewing the information and formulating their response and questions. IR and HR will meet with VPs and others in one-on-one meetings in January to start providing feedback. I am pleased to report that we remain on-track with our timeline.
- The Retirement Committee vetted initial proposals from prospective financial advisers.
 Two were selected as finalists, and their presentations were given to the committee last week. We are currently awaiting answers to some questions. We are looking into having consulting services available to employees on an individual basis, outside the TIAA perspective.
- There is only one more fall semester meeting left. Senate Committees should be working to meet due dates for charges if possible; reports and requests for action items are due Wednesday, Dec. 4.
