Addendum 1 - Academic Affairs Committee Report
The Academic Affairs Committee has finished reviewing the applications for the Senate

Research Empowerment Grants. Our plan is to announce these at the 3/11 Senate meeting.

Here are the 4 winners, by unanimous agreement of the Academic Affairs Committee:

1. **Sunjung Kim Thao -- Communication** Sciences **and** Disorders Project: "Interdisciplinary Experiential Learning Workshop: Fostering Collaborative Clinical Skills for Psychology and Speech Pathology Students to Serve Clients from Diverse Backgrounds"

Collaborator: Seungyeon Lee, Psychology & Counseling

Description: The proposed workshop will integrate theoretical instruction with hands-on experiential learning for students from Communication Sciences and Disorders (speech-language pathology) and Psychology. The workshop is designed to equip students with the **skills** necessary to effectively serve clients from diverse cultural, linguistic, and socioeconomic backgrounds.

# 2. Amrita Puri -- Biology

Project: "establish vital electroencephalography (EEG) infrastructure in our collaborative laboratory space"

Collaborators: Kenith Sobel, Department of Psychology and Counseling, and Jeffrey Padberg, Department of Biology

Description: This project involves a collaboration between faculty in the biology and psychology departments at UCA and experts at the Smith-Kettlewell Eye Research Institute with specific goals of 1) setting up an optimally functioning electroencephalography (EEG) research station (housed in the Puri lab) available to interdisciplinary neuroscience faculty across our campus, along with 2) functional integration of our existing EEG and eye tracking systems within this workstation, in order to 3) support UCA's neuroscience-related research, teaching, and outreach activities.

## 3. Adele Okoli -- School of Language and Literature

Project: "Global French Collaborative"

Collaborators: multiple faculty from History, Philosophy, English, Music, Film, Library, and French.

Description: Seed grant to empower the following activities in interdisciplinary French Studies research and creative activity across campus:

- faculty-organized research colloquia and conferences
- symposia highlighting faculty collaboration across academic units consortia for faculty working in interdisciplinary fields that do not have the institutional support structures of official departments or programs at UCA

## 4. Kathryn Carroll -- Nutrition & Family Sciences

Project: "Presentation at the 2025 American Association of Family and Consumer Sciences Annual Conference"

Collaborator: Rebekah Luong, Nutrition & Family Sciences

Description: Presentation will: 1) share with a national audience of educators and professionals how The Secret History of Home Economics can be used to help raise awareness of the Family and Consumer Sciences field and its relevance to students from a variety of academic disciplines, 2) Examine how themes explored in The Secret History of Home Economics reflect the evolving role of FCS in both education and broader societal issues, and 3) raise awareness of linkages between FCS and other disciplines in the social sciences, including applied economics.

Addendum 2 - DBIE

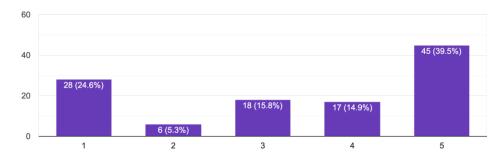
**DBIE** committee summary report

**Charge 1:** Review previous work on the Ombudsperson position proposal. Seek out best practices, detail the expectations of this position, and make a recommendation by December.

- The DBIE committee researched the ombudsperson positions at several universities, such as the North Carolina State University, Lamar University, Michigan State University, Arkansas State University.
- After careful examination and defining the complexity of the position, the Faculty Senate DBIE Committee determined that this position cannot be fulfilled by current UCA faculty members. The scope of an ombudsperson requires the position to be impartial, and the function of an ombudsperson would likely interfere with the role and responsibility of a faculty appointment.
- Sent out a survey to the UCA faculty to examine faculty perspectives regarding the
  possibility of creating an ombudsperson position to serve the university faculty.
- The survey was made available to UCA faculty for seven days. Here is a summary of the responses 114 (~20% UCA faculty) total responses, including 62 comments. Below is the graph representing the faculty responses to the survey (5 indicates Very Important, 1 indicates Not Important).

Considering the scope of the office as described above, should UCA create an ombudsperson position?

- Following the discussion on the survey responses, the DBIE committee voted on
  whether or not to draw a resolution. Among the six attending faculty, three voted in favor,
  and three were opposed. Therefore, the DBIE Committee decided to approach the
  senate body to discuss the results of the survey and consider recommending the next
  steps for the DBIE Committee in relation to the charge above.
- Faculty Senate discussion The discussion among senators resulted in no definitive recommendation for establishing an ombudsperson position at this time. Similar to the feedback from our survey and committee discussions, there appears to be an acknowledgment of the usefulness of an ombudsperson role for faculty and staff; however, a resolution urging the university administration to consider adding this position was not supported.

## Faculty Handbook- Board Policy No. 300

The UCA *Faculty Handbook* Committee recommends revisions to the opening pages, document, and chapters two, three, four, five, and seven, of the current *Faculty Handbook*. The following is a summary of the recommended revisions:

- Opening Pages:
  - Cover page: modify date of the document
  - o Title page: modify date of Board approval (pg. i)
  - o Table of Contents: modify page numbers (pg. iv-vii)
- Document: modify alphabetical order of headings
- Chapter Three:
  - o 3.II.E.: add Minimum Teaching Qualifications (pg. 12)
  - o 3.III.B.3.b.: change minimum teaching qualifications (pg. 16)
  - o 3.IV.B.1.b.i: change minimum teaching qualifications (pg. 20)
  - 3.IV.C.1.: change minimum teaching qualifications (pg. 20)
  - o 3.IV.C.2.: change minimum teaching qualifications (pg. 21)
- Chapter Seven:
  - o II.I.: add Institutional Biosafety Committee (pg. 69)
  - o II.R.2.a-g: change membership requirements of UCA Core Council (pg. 75)
    - II.T.1.: change senate to Faculty Senate (pg. 75)

The recommendations of the *Faculty Handbook* Committee have been considered and endorsed by the Faculty Senate, and other appropriate administrators.

Therefore, the President recommends the following resolution to the Board of Trustees.

"BE IT RESOLVED: That the Board of Trustees hereby approves the above revisions to the UCA Faculty Handbook.
