- President's Comments: President Davis
 - As of today (4/8), UCA's budget has not been approved by the Legislature
 - We will continue to monitor what is going on in Little Rock, but the budget is the President's first priority at this point in time

Questions from Senate to President Davis:

Q:Is the State voting on all of our budget, or only those funds provided by the State?

A:The Assembly approves the spending of all of our funds.

Q:When would the ACCESS bill take effect if approved? A:There is no emergency clause so far, so 90 days out..

Q: What might we expect with the recent Presidential Executive order regarding the USDOE and accrediting organizations?

A: This order will allow more organizations/states to enter the field and become an accrediting body. For example, the State of Arkansas could be an accreditation body.

Provost's Comments: Provost Hargis

- All academic programs go through self study and/or accreditation. Next week UCA's Undergraduate Core will be undergoing their first external review since the UCA Core was restructured ten years ago
- Strategic Planning Update The public data collection phase has been completed with an excellent representation from students, faculty, staff and the community at large.

- Deanna Rice (former FS COE) is present to express her gratitude for the kindness and support she has received during cancer treatment from the Senate and her colleagues here at UCA.

Q: Do we want box lunches for the meeting of April 29?

A: Yes.

Constituent Concerns-Received Online:

Q: Constituent questions the expenditure of funds on "color, glossy flyers" for CETAL, and feels academic departments need more budget for higher-quality operation compared to "non-instructional" programs.

A: Response from Assoc. Provost Kurt Boniecki: "...two flyers...were distributed to all faculty mailboxes as part of CETAL's outreach to ensure that all faculty are fully aware of the LMS review, how to connect with CETAL, and professional development opportunities for them this summer. While CETAL also uses UCA Inform to announce their events and activities, in their experience, not all of the faculty read UCA Inform when it is delivered to their email inboxes and therefore some of the faculty miss out on the opportunities that the university has invested in to benefit them. These flyers cost a total of \$377 for 1,000 copies (500 of each). In my opinion, this is money well spent if it reaches more faculty members and inspires greater participation in the LMS review and CETAL professional development activities. Indeed, as of today, approximately 100 faculty members have requested sandboxes in the three LMS platforms that will allow them to test drive the functionality of each. The vast majority of CETAL's M&O budget directly supports the faculty through faculty development grants, stipends for instructional consultants, and food and materials for professional development events (e.g., lunch and learns, new faculty orientation, day-long mini-conferences and summer institutes). The remainder of the budget (about 10%) is used to support the faculty indirectly through technology updates and professional development for our instructional designers whose job it is to help the faculty.

I think that all units on campus empathize with the constituent's concern about M&O budgets. CETAL would certainly like to provide more than it can as well. But, a \$377 expenditure to build awareness among faculty about critically time-sensitive activities that directly impact their teaching is not the example of M&O excess that the constituent believes it to be. Over the years, CETAL has advocated for funding on behalf of faculty, increasing money for faculty development grants and securing faculty stipends for summer institutes. Where the university spends its money should reflect its priorities, and that is a conversation worthy of our shared governance. However, I would hope that the Faculty Senate would agree that supporting faculty development and teaching excellence should be a priority of this university.

 - o 3.II.E.: add Minimum Teaching Qualifications (pg. 12)
 - o 3.III.B.3.b.: change minimum teaching qualifications (pg. 16)
 - o 3.IV.B.1.b.i: change minimum teaching qualifications (pg. 20)
 - o 3.IV.C.1.: change minimum teaching qualifications (pg. 20)
 - o 3.IV.C.2.: change minimum teaching qualifications (pg. 21)
- Chapter Seven:
 - o II.I.: add Institutional Biosafety Committee (pg. 69)
 - o II.R.2.a-g: change membership requirements of UCA Core Council (pg. 75)
 - o II.T.1.: change senate to Faculty Senate (pg. 75)
