Our mathematics education faculty are keenly aware of the shortage area and look for student who might consider mathematics teaching as a part of their mathematics program. We replicate the UTeach model for preparing mathematics teachers, so math majors do not have to choose between their B.S. in mathematics and a B.S.E.

Each program has designed field-based assignments to ensure that all candidates have experiences in a variety of school settings and with: (1) students from at least two ethnic groups; (2) students with exceptionalities; and (3) students who are English language learners. Further, assessment measures throughout the unit require candidates to demonstrate (1) their knowledge of multiple instructional/assessment/intervention strategies for various learning styles; (2) their ability to link to students' experiences and cultures to learning experiences; (3) capacity to incorporate multiple perspectives in their instruction and planning; and (4) how to make appropriate accommodations/modifications for the students with which they work. The UCA EPP prepares candidates to integrate technology effectively through a stand-alone technology class required of all candidates as well as a technology initiative integrated across the curriculum. In the stand-alone technology class, candidates are trained on content related to the ISTE standards as well as the TPACK and SAMR models. Additionally, candidates are required to complete Google Certification (Level 1) and Apple Teacher training. In select programs and courses, students use mobile technology through the EPP's one-to-one mobile technology initiative. Candidates final portfolio in that class are assessed against the ISTE standards. Additionally, all undergraduate teacher education programs are involved in the COE mobile 1:1 initiative. Mobile technology content and pedagogy are integrated across candidates' programs of study and assessed via targeted questions in multiple key assessments and surveys at various points in program progression. Candidates also experience targeted professional development from the Arkansas Department of Education to analyze data related to school and teacher-level impact through the Student GPS data tool maintained by the state department of education. These tools are embedded in candidates' assessment classes as well and used as a foundational part of their curriculum. Candidates are also required to gather data and analyze data around their impact on student learning in their final clinical experience and are expected to enter and weight data in a macro-enabled spreadsheet in order to represent data via various chart, graph, and table representation options. Candidates are prepared for this via a formative assessment in their coursework prior to the final clinical experience and supported through targeted PD in preparation for this key assessment The UCA EPP prepares candidates to implement Universal Design for Learning

by embedding the elements of UDL in all lesson plan templates and supporting materials. Candidates are trained in writing each lesson to incorporate and articulate UDL components as part of the lesson writing template. Candidate use of UDL principle is assessed in their lesson planning activities.
