## **2026** Arkansas Model United Nations (AMUN)

## **Country Assignments**

## **Guidelines:**

- 1. Initial country assignments are made following the previous AMUN conference. Subsequently, country assignments and changes to existing country assignments may be made at any time prior to the start of the AMUN conference. If a participating high school does not expect to be able to bring delegates to represent one or more countries that have been previously assigned, the faculty advisor or sponsor should contact the AMUN Liaison prior to the conference. There is a limit of 12 country assignments (12 delegations) and 72 students (72 delegates) per participating high school. Each participating high school may be assigned a maximum of two countries with seats on the Security Council, a maximum of two countries with seats on the Historical Security Council (HSC). Any vacant seats on the Security Council, HSC, and MICJ will be opened to any of the participating high schools about two months prior to the start of the AMUN conference.
- 2. Delegations may assign only one "official delegate" to each of the committees and councils. However, delegations may choose to assign one "codelegate" to each of the three main General Assembly (GA) committees. Co-delegates in the main GA committees may participate in the committee sessions (including speaking), but they are not permitted to be nominated for Rapporteur or Outstanding Delegate awards in the committees. Co-delegates may not be assigned to the Security Council, HSC, MICJ, Economic & Social Council (ECOSOC), Human Rights Council (HRC), Executive Board of the World Health Organization (WHO), and the Novice General Assembly (GA) Committee. Each delegation, whether represented by one delegate or two delegates, may only cast one vote on each motion, amendment, and resolution in the three main GA committees.
- 3. Participating high schools should make a reasonable effort to fill all of a country's committee seats, particularly the seats on the three main General Assembly (GA) committees. Outstanding delegation awards are based in part on delegate performance in only the three main GA committees, since these are the only committees in which each country has seats. Participating high schools should try to fill all of a country's committee seats before assigning delegates to serve as co-delegates in the three main GA committees.
- 4. Countries or other entities designated with "Observer Status" are not full members of the UN. Delegates representing countries or other entities with "Observer Status" may participate in discussions and speak during formal and informal committee sessions. These delegates may participate in "placard votes" on procedural matters (e.g. motions to recess or adjourn), but they may not vote on substantive matters (e.g. motions to adopt an amendment or resolution). During a roll call for the purpose of establishing quorum, delegates representing states or other entities with "Observer Status" should indicate "present" when called upon.
