# V. Senate Committee Reports

- A. Courtesy
  - 1. Discussion about sending emails to retirees instead of cards.

# VI. University Committee Reports

# A. Strategic Planning Committee

 Committee met and discussed the adopted KPI's; you can find them on the <u>UCA website</u>. First annual KPI report will be submitted to the Board of Trustees May 2024. Next meeting will be September 29, 2023

## B. Council of Student Success

- 1. Wrapped up our discussions for the year with scholarships, Admitted Students Days, "Cost of Attendance" sheet, KPI's and ended the discussion with problems that the committee might tackle next year: decline in male enrollment, mental health and fatigue among all employees and students, and continuing work on non-payments.
- 2. Huge shout out to Financial Aid, IT, Student Accounts and Admissions. The "Cost to Attend" sheet will be a huge game changer for incoming and current students. It will give them a more personalized look at their aid and how much more it will cost to attend. We are looking to use it going forward with SOAR being our next endeavor.

## C.. Veterans

1. Invited a 2 star general to the next event. The theme will be "Legacy of Service". Seeking veteran owned food vendors to serve that day.

#### VII. Constituent Concerns

A. Health Benefits concerns: Wellness committee response from HR Taylor May:

"I would like to reiterate Amy's response below. In addition, even though we currently do not cover weight loss surgery, we do an annual assessment of our plan and this topic always makes an appearance. We continue to do our research with self-funded peer institutions so that our plan can remain competitive and provide great coverage for our employees. In regards to your other questions, I do have some additional information from Blue Advantage regarding our plan's coverage. Home Birth - This is covered under the uA plan when services are rendered by a certified nurse midwife. This is also true for all our lines of business. Assessments for mental disorders - For the UCA plan, some are covered under mandated preventive benefits (depression and alcoholism); others would default to standard reimbursement rates. This is also true for all our lines of business.

Lastly, I know that sometimes understanding a summary plan document can be a bit confusing and that is what our team is here to help with. We do provide the Dental Plan Summary Documents on our website, which does show that major services, such as crowns, are covered at 50%, however, additionally, it clearly states that there is a \$1,250 per calendar year maximum per member, which I think is where the confusion lies."

- B. Human Resources Hiring Notification A regret courtesy call to applicants has been recommended. Discussion needed regarding the time frame this should happen and if there is a template for the recommended script to use.
- C. CAT/Maternity Leave Governor Sanders signed a new bill, <u>SB 426</u> where the wording changes from "up to four weeks" to "up to twelve weeks" for leave. President Herrera will get with HR to see if UCA is going to implement. It is understood that the employee must exhaust all vacation, sick and catastrophic leave available. This offers job protections if still out of work after all banked leave is gone.
- D. Concern was brought to the Senate about an employee having to print their own certificate from the employee service awards. The concern has been passed onto the committee and President Davis. (< link to certificates>)
- E. Research is ongoing regarding certain student fees for staff that are taking university courses.

Senator Eslinger proposed a motion to change Staff Senate by-laws to disburse a stipend plus fringe benefits (not to exceed state maximum salary for position classification) to the outgoing Staff Senate President at the end of their term. Studies performed indicated that this request is in line with what the Presidents of Faculty Senate and the Student Government Association are offered for their service. More information is needed before an official motion is brought forth to the senate for approval.
