## VII. Constituent Concerns/Communication

- A. Constituent Concern: Vending Machines
  - Outreach from President Fricks: "Good afternoon Cassandra, I am reaching out about constituent concerns Staff Senate has received regarding the vending machines. Below are some of the examples I've received.(1) Bernard Hall Drink Machine Went missing for a while, came back unplugged, and later appeared to be plugged up but still not functioning properly (2) Harrin Hall Snack Machine Doesn't stay stocked on a regular basis (3) Schichtl Hall Drink Machine The machine is a lottery system. What you hit isn't what you get. If you hit Pepsi, you get Pepsi Zero. If you hit Pepsi Zero, you get Mountain Dew. What should staff do

- if these issues continue to occur? Is there a process for reporting these issues? Thanks for all of your help!"
- 2. Response Cassandra McCuien Smith, Director of Procurement, Construction, Travel and Card Services: "Hey Veneta, The Pepsi issues are reported to the Student Center. I am notified and then I contact Pepsi. Unfortunately, we are not the only campus having issues with Pepsi. My other colleagues are expressing the same issues at their schools. As of Monday, we have been assigned a new maintenance person. He lives here in Conway and seems to be willing to take care of us. All of the issues you have mentioned have already been reported. But, if they have not been fixed to date I will report them again. The snack machine vendor is excellent, so that is rare. I'll certainly let him know. Thanks for letting me know."
- 3. Senator Turner- Issues with vending machines can be reported to the Student Center to refund the money.
- B. Why can't Professional Development money be given in advance instead of a reimbursement?
  - 1.Response from President Fricks: "Thank you for reaching out. We understand the financial hardship on some departments to provide funds for employee professional development prior to receiving Staff Senate funding. We've decided to continue to follow our process to reimburse departments for professional development expenses after the experience occurs. We want to be able to confirm that experiences have been completed prior to disbursing funds. Information for how staff should provide documentation and complete TR1s are provided in all award letters. "
- C. Requesting the backing of Staff Senate to require Faculty to use the new LMS.
  - 1. Response from President Fricks: "President Davis has been to Faculty Senate to talk about LMS. We will leave in Faculty Senate's hands.
  - D. I am writing to respectfully request that the Staff Senate consider advocating for priority registration for UCA Staff who are enrolled in courses under the university's tuition remission program. Providing staff with the opportunity to register early would not only enhance the value of the tuition remission benefit, but also offer meaningful support to departments across campus. With early access to course registration, staff members would be better able to select classes that align with both their educational goals and their work responsibilities. This balance is essential in ensuring continued productivity within departments while also promoting the professional development of employees.

By allowing staff to plan their class schedules around departmental needs, we can minimize disruptions and better maintain operational efficiency. Furthermore, this adjustment would reflect UCA's continued commitment to fostering a culture of learning and development among its employees.

1.Response from President Fricks: "Thank you for reaching out and for thoughtfully sharing your perspective on staff priority registration. The Staff Senate truly values ideas that promote professional development and strengthen the experience of UCA employees who are also pursuing their educational goals. After reviewing your request, we confirmed that registration access for all students — including staff enrolled through the tuition

remission program — follows the university's established registration schedule. Registration windows are assigned based on a variety of factors such as student classification, special programs, and other designated groups. These timeframes are designed to ensure an equitable and consistent process for all members of the campus community.

While staff are not eligible for early or priority registration, we understand the uniqueness of balancing coursework and departmental responsibilities. We encourage staff to plan accordingly using the published registration timeline, available here: <a href="Spring">Spring</a> 2026 Registration Schedule. Please know that the Staff Senate appreciates your advocacy and commitment to continued learning. We remain dedicated to elevating staff voices and exploring opportunities that enhance professional development and work-life balance.
