Strategic Plan Committee Minutes of the Zoom Meeting Friday, April 19, 2024

Business:

Provost Poulter called the meeting to order at 3:04 p.m.

- 1. Proposed language change for Goal Three of the UCA Strategic Plan Provost Poulter
 - a. Dean Hargis made a motion to approve the proposed amendment that "UCA will prioritize attracting and retaining employees at competitive market salaries". Jenny Ruud seconded the motion. Discussion followed:
 - i. Should salary compression be addressed as well or is it implied? Leveling up all salaries is temporary and an on-going problem for any non-unionized business. The Strategic Plan goals are fluid and on-going which allows the university to adjust as needed and since there are standing committees that consistently review faculty and staff salaries this need not be a static decision. It is understood the term "competitive" encompasses issues such as salary compression.
 - ii. Provost Poulter called for a vote. The motion passed, all in favor.
 - iii. The new amendment will be added to the Strategic Plan and presented to the Board of Trustees in May.
- 2. UCA Peer Institutions Amber Hall
 - Amber presented a list of 19 peer institutions from across the country who share similar KPIs in graduation rates, one-year retention rates, Pell grant metrics and minority enrollments. The Carnegie classification and HLC accreditation status were also considered when compiling the list.
 - a. Stephen O'Connell made a motion to accept the proposed list. Brent Shires seconded the motion. Discussion followed:
 - i. Why isn't Arkansas State University on the list since the previous list of Peer and Aspirant Institutions included them? Amber indicated the Carnegie Classification for ASU had changed to a doctoral / high research institution.
 - ii. Amber called for a vote. The motion passed, eight in favor and one abstaining.
- 3. Key Performance Indicators Amber Hall
 - Amber presented the updated and on-going KPIs.
 - a. John Toth made a motion to accept the KPIs. Lori Ross seconded the motion. The motion passed, all in favor.
 - b. The KPIs will be presented to the Board of Trustees in May.

4. Other Business

This is the final SPC meeting for Provost Poulter. As the in-coming Provost, Michael Hargis will chair future SPC meetings and will appoint a new representative from the Council of Deans.
