

COVID-19 Update: May 15, 2020 - Resources for Phased Return

Faculty and Staff:

I am reaching out today to share a few important updates with you regarding plans for our phased return to campus and the fall semester.

First, I would like to let you know that I have accepted an invitation to join the Higher Education Working Group for the Governor's Economic Recovery Task Force. The group will be working closely with members of the Economic Recovery Task Force as well as representatives of the Arkansas Department of Education and the Arkansas Department of Health to develop strategies to help the state move forward. I participated in the first meeting yesterday, and it centered on planning and preparation for reopening colleges and universities in August, with a specific focus on testing and tracing capacity. The work of this group has just begun and will continue for at least the next eight weeks. We are pleased to have a seat at the table to ensure that the policies and procedures we plan to implement are consistent with those of the state of Arkansas.

Last week I referenced our internal working groups that are tasked with preparing for all aspects of our phased return to campus this summer and our opening to students in the fall. These ad hoc groups are an extension of our Pandemic Planning and Response Team. We know employees and students will have many questions about what to expect as we return to campus, and we will be updating you as both information and guidance are finalized.

Attached is a PDF that contains a description and current roster for each working group. Leadership for each group was pulled from the Pandemic Planning and Response Team, and group members were selected based on their functional or content-specific role. Groups are consulting with other key stakeholders on and off campus as they conduct their work. Below, find a listing of those working groups.

Finally, last week we emailed a <u>framework</u> for a phased return to campus for faculty and staff. In just a few minutes, you will receive an email from the Office of Human Resources that will point you to several important documents and tools that are intended to answer many of the questions and concerns you

may have as we navigate personnel matters in the coming months. The communication from HR initially links to a set of frequently asked questions about returning to work and working remotely, important forms that will be available through HR, including an internal form to document an employee's approved remote work assignment, and a schedule of Zoom training opportunities for supervisors regarding our upcoming mode of operation.

Thank you again for your patience, positive attitudes, and tireless work as we all prepare for a safe, smooth transition back to campus.
